- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- 5 SECTION 1. The heading to Section 54.531, Education Code,
- is amended to read as follows: 6
- Sec. 54.531. STUDENT UNION <u>BUILDINGS</u> [BUILDING] FEES; THE 7
- UNIVERSITY OF TEXAS AT DALLAS. 8
- SECTION 2. Section 54.531, Education Code, is amended by 9
- amending Subsection (a) and adding Subsections (a-1) and (a-2) to 10
- 11 read as follows:
- 12 (a) The board of regents of The University of Texas System
- may levy a student union fee, not to exceed \$100 [\$60] per student 13
- for each regular semester and not to exceed \$50 [\$40] per student 14
- for each term of the summer session, for the sole purpose of 15
- 16 financing, constructing, operating, maintaining, and improving [a]
- student union buildings [building] for The University of Texas at 17
- Dallas. 18
- (a-1) The amount of the fee levied under this section may 19
- not be increased to an amount that exceeds by 10 percent or more the 20
- amount of the fee levied during the preceding academic year[+ 21
- provided, however, that the fee may not be increased above \$40 per 22
- 23 student for each regular semester and \$26.67 per student for each
- term of the summer session] unless the increase is approved by a 2.4

- 7 is amended to read as follows:

- 9 THE UNIVERSITY OF TEXAS AT DALLAS.
- SECTION 4. Section 54.5312(a), Education Code, is amended
- 11 to read as follows:
- 12 (a) The board of regents of The University of Texas System
- 13 may impose on each student enrolled at The University of Texas at
- 14 Dallas a student services buildings [building] fee for the sole
- 15 purpose of financing, constructing, operating, maintaining, and
- 16 improving [a] student services <u>buildings</u> [building] at the
- 17 university.
- 18 SECTION 5. The changes in law made by this Act apply
- 19 beginning with fees imposed for the 2024 fall semester.
- 20 SECTION 6. This Act takes effect September 1, 2023.
