- 2 relating to exceptions to laws prohibiting abortion.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. The heading to Section 170.002, Health and
- 5 Safety Code, is amended to read as follows:
- 6 Sec. 170.002. PROHIBITED ACTS; EXEMPTIONS [EXEMPTION].
- 7 SECTION 2. Section 170.002, Health and Safety Code, is
- 8 amended by amending Subsection (a) and adding Subsection (b-1) to
- 9 read as follows:
- 10 (a) Except as provided by Subsections [Subsection] (b) and
- 11 (b-1), a person may not intentionally or knowingly perform an
- 12 abortion on a woman who is pregnant with a viable unborn child
- 13 during the third trimester of the pregnancy.
- 14 (b-1) Subsection (a) does not prohibit a physician from
- 15 performing an abortion if:
- 16 <u>(1) the pregnant woman is 35 years of age or</u> older or
- 17 has a high-risk condition, as determined by the physician; or
- 18 (2) the pregnancy resulted from in vitro
- 19 <u>fertilization</u>.
- SECTION 3. Section 170A.002, Health and Safety Code, is
- 21 amended by adding Subsection (b-1) to read as follows:
- 22 (b-1) The prohibition under Subsection (a) does not apply
- 23 if:
- 24 (1) the pregnant woman is 35 years of age or older or

- 1 has a high-risk condition, as determined by a physician; or
- 2 (2) the pregnancy resulted from in vitro
- 3 fertilization.
- 4 SECTION 4. Section 171.046, Health and Safety Code, is
- 5 amended by adding Subsection (d) to read as follows:
- 6 (d) The prohibitions and requirements under Sections
- 7 <u>171.043</u>, <u>171.044</u>, and <u>171.045(b)</u> do not apply to an abortion
- 8 performed if:
- 9 (1) the pregnant woman is 35 years of age or older or
- 10 has a high-risk condition, as determined by a physician; or
- 11 (2) the pregnancy resulted from in vitro
- 12 fertilization.
- 13 SECTION 5. Section 171.063, Health and Safety Code, is
- 14 amended by adding Subsection (c-1) to read as follows:
- 15 (c-1) The restriction on the provision of an
- 16 abortion-inducing drug under Subsection (c)(6) does not apply if:
- 17 (1) either:
- 18 (A) the pregnant woman is 35 years of age or older
- 19 or has a high-risk condition, as determined by the physician; or
- 20 (B) the pregnancy resulted from in vitro
- 21 fertilization; and
- 22 (2) based on the physician's reasonable medical
- 23 judgment and the gestational age of the pregnancy, the provision of
- 24 the abortion-inducing drug will be effective and does not pose a
- 25 risk to the pregnant woman.
- SECTION 6. The heading to Section 171.102, Health and
- 27 Safety Code, is amended to read as follows:

- 1 Sec. 171.102. PARTIAL-BIRTH ABORTIONS PROHIBITED;
- 2 EXCEPTIONS.
- 3 SECTION 7. Section 171.102, Health and Safety Code, is
- 4 amended by adding Subsection (c) to read as follows:
- 5 (c) Subsection (a) does not apply to a physician who
- 6 performs a partial-birth abortion if:
- 7 (1) the pregnant woman is 35 years of age or older or
- 8 has a high-risk condition, as determined by the physician; or
- 9 (2) the pregnancy resulted from in vitro
- 10 <u>fertilization</u>.
- 11 SECTION 8. The heading to Section 171.152, Health and
- 12 Safety Code, is amended to read as follows:
- 13 Sec. 171.152. DISMEMBERMENT ABORTIONS PROHIBITED;
- 14 EXCEPTIONS.
- SECTION 9. Section 171.152(a), Health and Safety Code, is
- 16 amended to read as follows:
- 17 (a) A person may not intentionally perform a dismemberment
- 18 abortion unless:
- 19 (1) the dismemberment abortion is necessary in a
- 20 medical emergency;
- 21 (2) the pregnant woman is 35 years of age or older or
- 22 has a high-risk condition, as determined by a physician; or
- 23 (3) the pregnancy resulted from in vitro
- 24 fertilization.
- 25 SECTION 10. The heading to Section 171.205, Health and
- 26 Safety Code, is amended to read as follows:
- 27 Sec. 171.205. EXCEPTIONS [EXCEPTION FOR MEDICAL

- 1 EMERGENCY]; RECORDS.
- 2 SECTION 11. Section 171.205, Health and Safety Code, is
- 3 amended by adding Subsection (a-1) to read as follows:
- 4 (a-1) Sections 171.203 and 171.204 do not apply to an
- 5 abortion performed or induced by a physician if:
- 6 (1) the pregnant woman is 35 years of age or older or
- 7 has a high-risk condition, as determined by the physician; or
- 8 (2) the pregnancy resulted from in vitro
- 9 fertilization.
- 10 SECTION 12. This Act takes effect immediately if it
- 11 receives a vote of two-thirds of all the members elected to each
- 12 house, as provided by Section 39, Article III, Texas Constitution.
- 13 If this Act does not receive the vote necessary for immediate
- 14 effect, this Act takes effect September 1, 2023.
