No. 1964 1 driver involved in the accident; (E) the owner of a vehicle or property damaged in 2 3 the accident; 4 (F) a person who has established financial 5 responsibility for a vehicle involved in the accident in a manner described by Section 601.051, including a policyholder of a motor 6 vehicle liability insurance policy covering the vehicle; 7 8 (G) an insurance company that issued an insurance policy covering a vehicle involved in the accident; 9 10 (H) an insurance company that issued a policy 11 covering any person involved in the accident; a person under contract to provide claims or 12 (I) underwriting information to a person described by Paragraph (F), 13 14 (G), or (H); 15 (J) a radio or television station that holds a license issued by the Federal Communications Commission; 16 17 (K) a newspaper that is: 18 (i) a free newspaper of general circulation or qualified under Section 2051.044, Government Code, to publish 19 legal notices; 20 (ii) published at least once a week; and 21 22 (iii) available and of interest to the 23 general public in connection with the dissemination of news; [or] 24 (L) any person who may sue because of death 25 resulting from the accident; or 26 (M) an employee or authorized representative of a 27 vehicle storage facility, as defined by Section 2303.002,
