A BILL TO BE ENTITLED AN ACT

relating to the release of a motor vehicle accident report to an authorized representative of a vehicle facility.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 550.065(c), Transportation Code, amended to read as follows:

- (c) On written request and payment of any required fee, the department or the governmental entity shall release the information
  - an entity described by Subsection (b);
- (2) the law enforcement agency that employs the peace officer who investigated the accident and sent the information to the department, including an agent of the law enforcement agency authorized by contract to obtain the information;
- (3) the court in which a case involving a person involved in the accident is pending if the report is subpoenaed; or
- (4)any person directly concerned in the accident or having a proper interest therein, including:

  (A) any person involved in the accident;
- (B) the authorized representative of any person involved in the accident;
  - (C) a driver involved in the accident;
- (D) an employer, parent, or legal guardian of a driver involved in the accident;
  - (E) the owner of a vehicle or property damaged in
