## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the authority of certain physicians and nurses to
3	practice in this state.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 155, Occupations Code, is amended by
6	adding Subchapter E to read as follows:
7	SUBCHAPTER E. RECOGNITION OF OUT-OF-STATE LICENSE
8	Sec. 155.201. AUTHORITY TO PRACTICE. (a) Notwithstanding
9	any other law, a person may practice medicine in this state without
10	obtaining a license under this subtitle if the person is licensed in
11	good standing as a physician in another jurisdiction that has
12	licensing requirements that are substantially equivalent to the
13	requirements for a license under this subtitle.
14	(b) Before engaging in the practice of medicine in this
15	state, the person must:
16	(1) notify the board of the person's intent to practice
17	in this state; and
18	(2) receive from the board confirmation that:
19	(A) the board has verified the person's license
20	in the other jurisdiction; and
21	(B) the person is authorized to engage in the
22	practice of medicine in accordance with this section.
23	(c) The person shall comply with all other laws and rules

applicable to the practice of medicine in this state.

- SECTION 2. Subchapter F, Chapter 301, Occupations Code, is
- 11 amended by adding Section 301.2515 to read as follows:
- 12 Sec. 301.2515. RECOGNITION OF OUT-OF-STATE LICENSE. (a)
- 13 Notwithstanding any other law, a person may practice nursing in
- 14 this state without obtaining a license under this chapter if the
- 15 person is licensed in good standing as a nurse in another
- 16 jurisdiction that has licensing requirements that are
- 17 substantially equivalent to the requirements for a license under
- 18 this chapter.
- 19 (b) Before engaging in the practice of nursing in this
- 20 <u>state</u>, the person must:
- 21 (1) notify the board of the person's intent to practice
- 22 in this state; and
- 23 (2) receive from the board confirmation that:
- 24 (A) the board has verified the person's license
- 25 in the other jurisdiction; and
- 26 (B) the person is authorized to engage in the
- 27 practice of nursing in accordance with this section.

- 16 Nursing shall adopt the rules required by Section 301.2515,
- 17 Occupations Code, as added by this Act.
- SECTION 4. This Act takes effect September 1, 2023.
