- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 2.004(b), Family Code, is amended to
- 7 read as follows:
- 8 (b) The application form must contain:
- 9 (1) a heading entitled "Application for Marriage
- 10 License, _____ County, Texas";
- 11 (2) spaces for each applicant's full name, including
- 12 the woman's maiden surname, address, social security number, if
- 13 any, date of birth, and place of birth, including city, county, and
- 14 state;
- 15 (3) a space for indicating the document tendered by
- 16 each applicant as proof of identity and age;
- 17 (4) spaces for indicating whether each applicant has
- 18 been divorced within the last 30 days;
- 19 (5) printed boxes for each applicant to check "true"
- 20 or "false" in response to the following statement: "I am not
- 21 presently married and the other applicant is not presently
- 22 married.";
- 23 (6) printed boxes for each applicant to check "true"
- 24 or "false" in response to the following statement: "The other

- 25 (9) a printed oath reading: "I SOLEMNLY SWEAR (OR

- 1 (10) (49) spaces immediately below the printed oath
- 2 for the applicants' signatures;
- 3 (11) [(10)] a certificate of the county clerk that:
- 4 (A) each applicant made the oath and the date and
- 5 place that it was made; or
- 6 (B) an applicant did not appear personally but
- 7 the prerequisites for the license have been fulfilled as provided
- 8 by this chapter;
- 9 (12) $[\frac{(11)}{(11)}]$ spaces for indicating the date of the
- 10 marriage and the county in which the marriage is performed;
- 11 $\underline{(13)}$ [$\underline{(12)}$] a space for the address to which the
- 12 applicants desire the completed license to be mailed; and
- (14) $[\frac{(13)}{}]$ a printed box for each applicant to check
- 14 indicating that the applicant wishes to make a voluntary
- 15 contribution of \$5 to promote healthy early childhood by supporting
- 16 the Texas Home Visiting Program administered by the Office of Early
- 17 Childhood Coordination of the Health and Human Services Commission.
- SECTION 2. Subchapter A, Chapter 2, Family Code, is amended
- 19 by adding Section 2.011 to read as follows:
- Sec. 2.011. CONFIDENTIALITY OF CERTAIN INFORMATION. If an
- 21 applicant for a marriage license has checked the box described by
- 22 Section 2.004(b)(8), the county clerk may not:
- (1) publicly publish the personally identifying
- 24 information of either applicant, other than the names of the
- 25 applicants; or
- 26 (2) release a copy of the application or license that
- 27 includes the personally identifying information of either

- 1 applicant, other than the names of the applicants, to anyone other
- 2 than an applicant named on the license or the applicant's legal
- 3 <u>representative</u>.
- 4 SECTION 3. Section 2.402(b), Family Code, is amended to
- 5 read as follows:
- 6 (b) The declaration form must contain:
- 7 (1) a heading entitled "Declaration and Registration
- 8 of Informal Marriage, _____ County, Texas";
- 9 (2) spaces for each party's full name, including the
- 10 woman's maiden surname, address, date of birth, place of birth,
- 11 including city, county, and state, and social security number, if
- 12 any;
- 13 (3) a space for indicating the type of document
- 14 tendered by each party as proof of age and identity;
- 15 (4) printed boxes for each party to check "true" or
- 16 "false" in response to the following statement: "The other party is
- 17 not related to me as:
- 18 (A) an ancestor or descendant, by blood or
- 19 adoption;
- 20 (B) a brother or sister, of the whole or half
- 21 blood or by adoption;
- (C) a parent's brother or sister, of the whole or
- 23 half blood or by adoption;
- (D) a son or daughter of a brother or sister, of
- 25 the whole or half blood or by adoption;
- 26 (E) a current or former stepchild or stepparent;
- 27 or

- 1 (F) a son or daughter of a parent's brother or

- 3 (5) a printed box for either party to check "Yes,
- 4 please keep the identifying information on this form confidential"
- 5 in response to the following statement: "If either party named on
- 6 this form is or has been a victim of family violence, dating
- 7 violence, sexual assault, stalking, or human trafficking and would
- 8 like the identifying information on this form to be kept
- 9 confidential, check the following box.";
- 10 (6) a printed declaration and oath reading: "I
- 11 SOLEMNLY SWEAR (OR AFFIRM) THAT WE, THE UNDERSIGNED, ARE MARRIED TO
- 12 EACH OTHER BY VIRTUE OF THE FOLLOWING FACTS: ON OR ABOUT (DATE) WE
- 13 AGREED TO BE MARRIED, AND AFTER THAT DATE WE LIVED TOGETHER AS
- 14 HUSBAND AND WIFE AND IN THIS STATE WE REPRESENTED TO OTHERS THAT WE
- 15 WERE MARRIED. SINCE THE DATE OF MARRIAGE TO THE OTHER PARTY I HAVE
- 16 NOT BEEN MARRIED TO ANY OTHER PERSON. THIS DECLARATION IS TRUE AND
- 17 THE INFORMATION IN IT WHICH I HAVE GIVEN IS CORRECT.";
- (7) $[\frac{(6)}{(6)}]$ spaces immediately below the printed
- 19 declaration and oath for the parties' signatures; and
- (8) $\left[\frac{7}{1}\right]$ a certificate of the county clerk that the
- 21 parties made the declaration and oath and the place and date it was
- 22 made.
- SECTION 4. Subchapter E, Chapter 2, Family Code, is amended
- 24 by adding Section 2.406 to read as follows:
- 25 Sec. 2.406. CONFIDENTIALITY OF CERTAIN INFORMATION. If a
- 26 party to a declaration of informal marriage has checked the box
- 27 described by Section 2.402(b)(5), the county clerk may not:

- 1 (1) publicly publish the personally identifying
- 2 information of either party, other than the names of the parties; or
- 3 (2) release a copy of the declaration that includes
- 4 the personally identifying information of either party, other than
- 5 the names of the parties, to anyone other than a party named on the
- 6 declaration or the party's legal representative.
- 7 SECTION 5. Section 194.004, Health and Safety Code, is
- 8 amended by amending Subsection (a) and adding Subsection (c) to
- 9 read as follows:
- 10 (a) Except as otherwise provided by this section,
- 11 the [The] vital statistics unit shall furnish on request any
- 12 information it has on record relating to any marriage, divorce, or
- 13 annulment of marriage.
- 14 (c) If a party to a marriage has checked the box described by
- 15 <u>Section 2.004(b)(8) or 2.402(b)(5)</u>, Family Code, on the marriage
- 16 <u>license application or declaration of informal marriage, as</u>
- 17 applicable, the vital statistics unit may not furnish any
- 18 personally identifying information on record relating to the
- 19 marriage, other than the names of the parties to the marriage, to
- 20 anyone other than a party to the marriage or the party's legal
- 21 representative.
- 22 SECTION 6. The changes in law made by this Act apply only to
- 23 an application for a marriage license filed, or a declaration of an
- 24 informal marriage executed, as applicable, on or after the
- 25 effective date of this Act. An application filed or declaration
- 26 executed before the effective date of this Act is governed by the
- 27 law in effect on the date the application was filed or the

- 1 declaration was executed, and the former law is continued in effect
- 2 for that purpose.
- 3 SECTION 7. This Act takes effect September 1, 2023.
