1 (B) works with a licensed massage therapist. 2 (b-1) Except as provided by Chapter 243, Local Government Code, a political subdivision may not adopt a regulation of the type 3 described by Subsection (b) that is more restrictive for massage 4 5 therapists than for other health care professionals. 6 (c) A [Except as provided by Chapter 243, Local Government 7 Code, a] political subdivision may not adopt a regulation of the 8 type described by Subsection (b) that is more restrictive for [massage therapists or] massage establishments than for other 9 health care [professionals or] establishments, except that a more 10 restrictive regulation of the type described by Subsection (b) may 11 12 be adopted: (1) as provided by Chapter 243, Local Government Code; 13 14 (2) if regulating the hours of operation of a massage 15 establishment; or 16 (3) if the regulation relates to the location, 17 ownership, or operation of a massage establishment: 18 (A) where three or more arrests have occurred or 19 citations in lieu of arrest have been issued for an offense under Section 43.02, 43.021, 43.03, 43.04, 43.05, or 71.02, Penal Code; 20 21 (B) where an offense under Chapter 20A, or Section 34.02, 43.02, 43.021, 43.03, 43.04, 43.05, or 71.02, Penal 22 Code, occurred that resulted in a conviction; 23 24 (C) that is operating at a location where another massage establishment against which a sanction was imposed for a 25 26 violation of this chapter previously operated; or 27 (D) that is operating at a location where another
