A BILL TO BE ENTITLED

1 AN ACT

2 relating to the eligibility of certain events for funding under the
3 major events reimbursement program.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 478.0001(3), Government Code, as amended
6 by Chapters 10 (H.B. 1472), 102 (S.B. 1265), 605 (S.B. 1155), and
7 915 (H.B. 3607), Acts of the 87th Legislature, Regular Session,
8 2021, is reenacted and amended to read as follows:

8 Acts of the 87th Legislature, Regular Session, 2021, is reenacted
9 and amended to read as follows:

10 SECTION 3. Section 478.0053, Government Code, is amended to
11 read as follows:

12 Sec. 478.0053. EXEMPTION FROM CERTAIN ELIGIBILITY
13 REQUIREMENT FOR CERTAIN LARGE VENUES. Section 478.0051(b)(1) does
14 not apply to an event described by Section 478.0001(3)(M)
15 [~~478.0001(3)(H)~~]. If an endorsing municipality or endorsing county
16 requests the office to make a determination under Section 478.0102
17 for an event described by Section
18 478.0001(3)(M) [~~478.0001(3)(H)~~], the remaining provisions of this
19 chapter apply to that event as if the event satisfied the
20 eligibility requirements under Section 478.0051(b)(1).

21 SECTION 4. To the extent of any conflict, this Act prevails
22 over another Act of the 88th Legislature, Regular Session, 2023,
23 relating to nonsubstantive additions to and corrections in enacted
24 codes.

25 SECTION 5. This Act takes effect September 1, 2023.
