## A BILL TO BE ENTITLED

1	AN ACT	

- 2 relating to monetary assistance provided by the Department of
- 3 Family and Protective Services to certain relative or designated
- 4 caregivers.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 264.752(c), Family Code, is amended to
- 7 read as follows:
- 8 (c) The executive commissioner shall adopt rules necessary
- 9 to implement this subchapter. [The rules must include eligibility
- 10 criteria for receiving assistance and services under this
- 11 subchapter.
- 12 SECTION 2. Section 264.755, Family Code, as amended by
- 13 Chapter 315 (H.B. 4), Acts of the 85th Legislature, Regular
- 14 Session, 2017, is amended by reenacting and amending Subsections
- 15 (a), (b), (b-1), (c), and (f) to read as follows:
- 16 (a) The department shall, subject to the availability of
- 17 funds, enter into a caregiver assistance agreement with each
- 18 relative or other designated caregiver to provide monetary
- 19 assistance and additional support services to the caregiver. [ $\frac{The}{T}$
- 20 monetary assistance and support services shall be based on a
- 21 family's need, as determined by Subsection (b) and rules adopted by
- 22 the executive commissioner.
- 23 (b) The department shall provide monetary assistance under
- 24 this section to each relative or other designated  $[\frac{a}{a}]$  caregiver

- 1 [who has a family income that is less than or equal to 300 percent of
- 2 the federal poverty level]. Monetary assistance provided to a
- 3 caregiver under this section  $\underline{\text{must be equal to}}$  [ $\underline{\text{may not exceed 50}}$
- 4 percent of ] the department's minimum daily [basic] foster care
- 5 reimbursement rate for the child. [A caregiver who has a family
- 6 income greater than 300 percent of the federal poverty level is not
- 7 eligible for monetary assistance under this section.
- 8 (b-1) The department shall disburse monetary assistance
- 9 provided to a caregiver under Subsection (b) in the same manner as
- 10 the department disburses payments to a foster parent, including
- 11 making a rate increase effective on the same date the department
- 12 <u>implements a rate increase for the minimum daily foster care</u>
- 13 reimbursement rate. The department may not provide monetary
- 14 assistance to an eligible caregiver under Subsection (b) after the
- 15 first anniversary of the date the caregiver receives the first
- 16 monetary assistance payment from the department under this section.
- 17 The department, at its discretion and for good cause, may extend the
- 18 monetary assistance payments for an additional six months.
- 19 (c) Monetary assistance and additional support services
- 20 provided under this section may include:
- 21 (1) case management services and training and
- 22 information about the child's needs until the caregiver is
- 23 appointed permanent managing conservator;
- 24 (2) referrals to appropriate state agencies
- 25 administering public benefits or assistance programs for which the
- 26 child, the caregiver, or the caregiver's family may qualify;
- 27 (3) family counseling not provided under the Medicaid

- 1 program for the caregiver's family for a period not to exceed two
- 2 years from the date of initial placement;
- 3 (4) [if the caregiver meets the eligibility criteria
- 4 determined by rules adopted by the executive commissioner,
- 5 reimbursement of all child-care expenses incurred while the child
- 6 is under 13 years of age, or under 18 years of age if the child has a
- 7 developmental disability, and while the department is the child's
- 8 managing conservator; and
- 9 (5) [if the caregiver meets the eligibility criteria
- 10 determined by rules adopted by the executive commissioner,
- 11 reimbursement of 50 percent of child-care expenses incurred after
- 12 the caregiver is appointed permanent managing conservator of the
- 13 child while the child is under 13 years of age, or under 18 years of
- 14 age if the child has a developmental disability.
- 15 (f) If a person [who has a family income that is less than or
- 16 equal to 300 percent of the federal poverty level] enters into a
- 17 caregiver assistance agreement with the department, obtains
- 18 permanent managing conservatorship of a child, and meets all other
- 19 eligibility requirements, the person may receive an annual
- 20 reimbursement of other expenses for the child, as determined by
- 21 rules adopted by the executive commissioner, not to exceed \$500 per
- 22 year until the earlier of:
- 23 (1) the third anniversary of the date the person was
- 24 awarded permanent managing conservatorship of the child; or
- 25 (2) the child's 18th birthday.
- SECTION 3. Section 264.755(b-2), Family Code, is repealed.
- 27 SECTION 4. Section 264.755, Family Code, as amended by this

- 1 Act, applies to a caregiver assistance agreement entered into
- 2 before, on, or after the effective date of this Act.
- 3 SECTION 5. This Act takes effect September 1, 2023.
