A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to certain indefinite quantity contracts entered into by
- 3 the General Land Office in the event of a natural disaster.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 31.069, Natural Resources Code, is
- 6 amended by amending Subsections (a), (b), and (c) and adding
- 7 Subsections (i), (j), (k), and (l) to read as follows:
- 8 (a) The land office shall enter into indefinite quantity
- 9 contracts with vendors to provide [information management
- 10 services, construction services, including engineering services,
- 11 and other] services the land office determines may be necessary to
- 12 construct, repair, or rebuild property or infrastructure in the
- 13 event of a natural disaster.
- 14 (b) [A contract entered into under Subsection (a) may not
- 15 expire after May 1 of a calendar year.] The terms of a contract
- 16 under Subsection (a) must[+
- 17 $\left[\frac{(1)}{(1)}\right]$ provide that the contract is contingent on:
- 18 $\underline{\text{(1)}}$ [$\frac{\text{(A)}}{\text{(1)}}$] the availability of funds;
- 19 $\underline{\text{(2)}}$ [(B)] the occurrence of a natural disaster within
- 20 the term [not later than 48 months after the effective date] of the
- 21 contract; and
- (3) $[\frac{C}{C}]$ delivery of the services to an area of this
- 23 state declared by the governor or president of the United States
- 24 under law to be a disaster area as a result of the natural

- 2 [(2) have a term of four years].
- 3 (c) The land office shall ensure that it has contracts in
- 4 place under this section with vendors to provide [the] services
- 5 [described by Subsection (a)] that take effect immediately on the
- 6 expiration of a contract under this section.
- 7 (i) Except as provided by Subsection (h), the land office
- 8 may award a contract under this section to one or more vendors:
- 9 (1) on the basis of demonstrated competence and
- 10 qualifications to perform the services for which the land office
- 11 issues a request for qualifications; or
- 12 (2) using any other applicable state procurement
- 13 method.
- 14 (j) A contract under this section may include:
- 15 <u>(1)</u> a unit price book;
- 16 (2) a list of pre-priced work items; or
- 17 (3) another schedule identifying agreed prices for
- 18 services.
- 19 (k) A contract under this section that does not include the
- 20 items listed in Subsection (j) must require a vendor to submit a
- 21 price proposal for services on request by the land office.
- (1) The land office shall issue task, work, or purchase
- 23 orders for services under a contract entered into under this
- 24 section to the vendor that provides the best value to the land
- 25 office using the standard provided by Section 2155.074, Government
- 26 Code.
- 27 SECTION 2. The change in law made by this Act applies only

- $1\,$ to a contract for which the General Land Office first advertises or
- 2 otherwise solicits bids, proposals, offers, or qualifications or
- 3 makes a similar solicitation on or after the effective date of this
- 4 Act. A contract for which the General Land Office first advertises
- 5 or otherwise solicits bids, proposals, offers, or qualifications or
- 6 makes a similar solicitation before the effective date of this Act
- 7 is governed by the law in effect on the date the advertisement or
- 8 solicitation is made, and that law is continued in effect for that
- 9 purpose.
- 10 SECTION 3. This Act takes effect September 1, 2023.
