4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 3(a), Chapter 78, Acts of the 53rd

Legislature, Regular Session, 1953, is amended to read as follows:

7 (a) All powers of the District shall be exercised by a Board

8 of Directors. Such directors shall be appointed by a majority vote

9 of [for] the governing body of each of the cities contained in the

10 District. [In appointing the first directors for a city containing

11 5,000 population or more according to the most recent Federal

12 Census, the governing body of such city shall appoint one director

who shall serve to and including May 31, 1954, and one who shall

14 serve to and including May 31, 1955. In [May, 1954, and in] May of

15 each <u>even-numbered</u> year [<del>thereafter</del>], the governing <u>bodies</u> [<del>body</del>]

16 of <u>Avinger</u>, <u>Hughes Springs</u>, <u>Jefferson</u>, and <u>Ore City each</u> [such

18 on June  $\underline{1}$  [1st] of that year. In May of each odd-numbered year, the

19 governing bodies of Daingerfield, Lone Star, and Pittsburg each

20 shall appoint one director for a two year term beginning on June 1

21 of that year. [In appointing the first director for a city of less

22 than 5,000 population according to the most recent Federal Census,

the governing body of such city shall appoint one director who shall

24 serve to and including May 31, 1954. In May, 1954, and in May of

each even year thereafter, the governing body shall appoint one 1 director for the two year term beginning on June 1st of that year. 2 Each director shall serve for the director's [his] term of office as 3 herein provided, and thereafter until the director's 4 successor shall be appointed and qualified. No person shall be 5 appointed a director unless the person [he] resides in and owns 6 taxable property in the city from which the person [he] 7 8 No member of a governing body of a city  $[\tau]$  and no employee of a city shall be appointed as director. Such directors 9 shall subscribe the constitutional oath of office, and each shall 10 give bond for the faithful performance of the director's [his] 11 duties in the amount of Five Thousand (\$5,000.00) Dollars, the cost 12 of which shall be paid by the District. A majority shall constitute 13 14 a quorum. 15 SECTION 2. Section 6, Chapter 78, Acts of the 53rd Legislature, Regular Session, 1953, is amended to read as follows: 16 17 Sec. 6. When [any city,] the territory of a city [which] is [hereafter] annexed to the District, [contains 5,000 inhabitants or 18 19 more according to the most recent Federal Census, the governing body of the city shall appoint one director for the term ending the 20 following May 31st, and one director for the term ending one year 21 after the following May 31st, and in May of each year shall appoint 22 one director for a two year term the same as provided in this Act for 23 24 cities originally included in the District. If such city contains less than 5,000 inhabitants according to the most recent Federal 25 26 Census, the governing body of the city shall appoint one director whose term shall expire the following May  $31 \ [31st]$ , and in May of 27

- 1 each second year thereafter shall appoint one director for a two
- 2 year term beginning on June 1 of that year and expiring on May 31 two
- 3 years later. [Whenever such city may later attain a population of
- 4 5,000 or more according to the Federal Census, it shall thereafter
- 5 be entitled to two directors to be appointed as herein provided.
- 6 SECTION 3. (a) A person who is appointed by the governing
- 7 bodies of the cities of Avinger, Hughes Springs, Jefferson, or Ore
- 8 City and is serving as a director of the Northeast Texas Municipal
- 9 Water District on the effective date of this Act shall continue to
- 10 serve as a director for a term of office that expires May 31, 2024.
- 11 (b) As soon as practicable after the effective date of this
- 12 Act, the governing bodies of the cities of Daingerfield, Lone Star,
- 13 and Pittsburg shall each appoint a person to serve as a director of
- 14 the Northeast Texas Municipal Water District for a term of office
- 15 that begins June 1, 2023, and expires May 31, 2025.
- 16 SECTION 4. (a) The legal notice of the intention to
- 17 introduce this Act, setting forth the general substance of this
- 18 Act, has been published as provided by law, and the notice and a
- 19 copy of this Act have been furnished to all persons, agencies,
- 20 officials, or entities to which they are required to be furnished
- 21 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 22 Government Code.
- 23 (b) The governor, one of the required recipients, has
- 24 submitted the notice and Act to the Texas Commission on
- 25 Environmental Quality.
- 26 (c) The Texas Commission on Environmental Quality has filed
- 27 its recommendations relating to this Act with the governor, the

- 1 lieutenant governor, and the speaker of the house of
- 2 representatives within the required time.
- 3 (d) All requirements of the constitution and laws of this
- 4 state and the rules and procedures of the legislature with respect
- 5 to the notice, introduction, and passage of this Act are fulfilled
- 6 and accomplished.
- 7 SECTION 5. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2023.
