4	SECTION 1. Chapter 607, Government Code, is amended by
5	adding Subchapter D to read as follows:
6	SUBCHAPTER D. QUARANTINE LEAVE FOR CERTAIN PUBLIC SAFETY EMPLOYEES
7	Sec. 607.151. DEFINITIONS. (a) In this subchapter:
8	(1) "Detention officer" means an individual employed
9	by the state to ensure the safekeeping of prisoners and the security
10	of a state penal institution in this state.
11	(2) "Emergency medical technician" means an
12	individual who is:
13	(A) certified as an emergency medical technician
14	under Chapter 773, Health and Safety Code; and
15	(B) employed by the state.
16	(3) "Firefighter" means a paid employee of the state
17	who:
18	(A) holds a position that requires substantial
19	knowledge of firefighting;
20	(B) has met the requirements for certification by
21	the Texas Commission on Fire Protection under Chapter 419; and
22	(C) performs a function listed in Section
23	143.003(4)(A), Local Government Code.
24	(4) "Health authority" has the meaning assigned by

- 2 (5) "Ordered to quarantine or isolate" means any
- 3 circumstance in which a person is not permitted to continue working
- 4 due to:
- 5 (A) a written or verbal directive by a health
- 6 authority or the employee's supervisor ordering the person to

- 8 communicable disease; or
- 9 (B) a written or verbal directive by a health

- 14 (6) "Peace officer" means an individual described by
- 15 Article 2.12, Code of Criminal Procedure, who is elected for,
- 16 employed by, or appointed by the state.
- 17 (b) Notwithstanding Section 607.001, in this subchapter,
- 18 "public safety employee" means a detention officer, emergency
- 19 medical technician, firefighter, or peace officer.
- Sec. 607.152. PAID QUARANTINE LEAVE FOR CERTAIN PUBLIC
- 21 SAFETY EMPLOYEES. (a) A state agency that employs public safety
- 22 <u>employees shall develop and implement a paid quarantine leave</u>
- 23 policy for public safety employees who are ordered to quarantine or
- 24 <u>isolate.</u>
- 25 (b) A paid quarantine leave policy must provide that a
- 26 public safety employee ordered to quarantine or isolate receive:
- 27 (1) all employment benefits and compensation,

- 1 including leave accrual, pension benefits, and health benefit plan
- 2 benefits for the duration of the leave; and
- 3 (2) reimbursement for reasonable costs related to the
- 4 quarantine, including lodging, medical, and transportation.
- 5 (c) The state agency may not reduce a public safety
- 6 employee's sick leave balance, vacation leave balance, or other
- 7 paid leave balance in connection with paid quarantine leave taken
- 8 in accordance with a policy adopted under this section.

- 21 <u>authority or the employee's supervisor ordering the person to</u>
- 22 refrain from reporting to duty after being exposed to a

- 25 SECTION 3. Section 180.008(b), Local Government Code, as
- 26 added by Chapter 685 (H.B. 2073), Acts of the 87th Legislature,
- 27 Regular Session, 2021, is amended to read as follows:

- 1 (b) The governing body of a political subdivision shall develop and implement a paid quarantine leave policy for fire fighters, peace officers, detention officers, and emergency medical technicians who are employed by, appointed by, or elected for the political subdivision and ordered to quarantine or isolate [due to a possible or known exposure to a communicable disease while on duty].
- SECTION 4. This Act takes effect immediately if it receives 9 a vote of two-thirds of all the members elected to each house, as 10 provided by Section 39, Article III, Texas Constitution. If this 11 Act does not receive the vote necessary for immediate effect, this 12 Act takes effect September 1, 2023.
