- 3 SECTION 3. The change in law made by this Act applies only
- 4 to a person who is arrested on or after December 1, 2023. A person
- 5 arrested before December 1, 2023, is governed by the law in effect
- 6 on the date the person was arrested, and the former law is continued
- 7 in effect for that purpose.
- 8 SECTION 4. This Act takes effect December 1, 2023, but only
- 9 if the constitutional amendment proposed by the 88th Legislature,
- 10 Regular Session, 2023, authorizing the legislature to set a minimum
- 11 amount of monetary bond for persons charged with stalking or an
- 12 offense involving family violence is approved by the voters. If
- 13 that amendment is not approved by the voters, this Act has no
- 14 effect.
