- 6 SECTION 1. Sections 521.060(a) and (c), Transportation
- 7 Code, are amended to read as follows:
- 8 (a) The department shall maintain in its files a record of
- 9 the name, address, and telephone number of each individual
- 10 identified by the holder of a driver's license or personal
- 11 identification certificate as an individual the holder authorizes
- 12 to be contacted in the event that the holder is injured or dies in or
