Subchapter F, Chapter 2303, Government Code, is amended by adding Section 2303.499 to read as follows: 6 Sec. 2303.499. CERTAIN REQUIREMENTS WAIVED DURING COVID 7 RELIEF PERIOD. (a) In this section, "COVID relief period" means 8 9 the period beginning March 1, 2020, and ending December 31, 2021. (b) Notwithstanding Section 2303.003(7)(C) or any other 10 law, the requirement that an employee perform at least 50 percent of 11 the person's service for the business at the qualified business 12 site to be a "qualified employee" is waived for an annual 13 14 certification or job retention period that includes the COVID relief period. 15 16 (c) A qualified business in compliance with this chapter before the COVID relief period that is eligible for a waiver under 17 Subsection (b) may elect to withdraw its project or activity from 18 19 designation as an enterprise project by December 31, 2023. A qualified business that withdraws its enterprise project 20 designation under this subsection is considered eligible for any 21 refund of state taxes under Section 2303.504 approved for the COVID 22 23 relief period, notwithstanding the requirements for meeting the definition of a new permanent job under Section 2303.401(1)(C) or a 24

retained job under Section 2303.401(2)(C).

SECTION 2. Section 151.429, Tax Code, is amended by adding 3 Subsection (g-1) to read as follows: 4

(d) This section expires December 31, 2030.

(g-1) The comptroller shall waive the requirements of 5 6 Subsection (g) for a qualified business that did not meet the 7 requirement that a qualified employee perform at least 50 percent 8 of the person's service for the business at the qualified business site, as defined by Section 2303.003, at any time during the period 9 beginning March 1, 2020, and ending December 31, 2021. 10 This subsection expires December 31, 2030. 11

SECTION 3. Section 2303.499, Government Code, and Section 12 151.429(g-1), Tax Code, as added by this Act, apply to any audit by 13 14 the comptroller of whether an enterprise project is eligible for a 15 tax refund under Section 151.429, Tax Code, that is not finally completed before the effective date of this Act. 16

17 SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2023. 21
