Section 373A.002, Local Government Code, is 13 14 amended by amending Subdivision (3-a) and adding Subdivision (3-b) to read as follows: 15 (3-a) "Low income household" means a household with a 16 gross income of not greater than 80 percent of the area median 17 family income, adjusted for household size, for the metropolitan 18 19 statistical area in which the municipality is located, as determined annually by the United States Department of Housing and 20 Urban Development. 21 (3-b) "Project costs" has the meaning assigned by 22 23 Section 311.002(1), Tax Code. 24 SECTION 3. Section 373A.003(a), Local Government Code, is

3 (1) a municipality with a population of more than 4 750,000 that is located in a uniform state service region with fewer 5 than 550,000 occupied housing units as determined by the most 6 recent United States decennial census; and
