5	SECTION 1. Subchapter C, Chapter 61, Education Code, is
6	amended by adding Section 61.0765 to read as follows:

8	board shall establish a pilot program under which the board awards
9	grants to participating public junior colleges to provide financial
10	assistance to educationally disadvantaged high school students for
11	all or part of the cost of enrolling in dual credit courses at the
12	college.
13	(b) The board shall select not more than 10 public junior
14	colleges in the small or medium public junior college peer group, as
15	identified by the board, to participate in the pilot program. In
16	selecting public junior colleges, the board shall, to the extent
17	practicable, ensure that at least one public junior college from
18	each region of the state is included.
19	(c) A participating public junior college must:
20	(1) use grant funds awarded under this section to
21	provide financial assistance to eligible students for all or part
22	of the cost of tuition and required fees for dual credit courses at
23	the college;
24	(2) work with high schools that partner with the

1 at an institution of higher education. 2 (e) Funds provided to an eligible student under the pilot program must be used for the cost of tuition or required fees for 3 dual credit courses at the participating public junior college. 4 (f) A public or private high school, including a home 5 school, that partners with a participating public junior college to 6 7 provide dual credit courses and elects to participate in the pilot program must provide to students in grade nine or the equivalent 8 information regarding dual credit opportunities and the funding 9 10 available for dual credit courses under the pilot program. (g) Not later than December 1, 2024, the board shall 11 12 evaluate the effectiveness of the pilot program and report the results of the evaluation to the legislature. (h) This section expires September 1, 2025.

3 SECTION 2. The Texas Higher Education Coordinating Board 4 shall establish the pilot program under Section 61.0765, Education 5 Code, as added by this Act, as soon as practicable following the 6 effective date of this Act.

7 SECTION 3. This Act takes effect immediately if it receives 8 a vote of two-thirds of all the members elected to each house, as 9 provided by Section 39, Article III, Texas Constitution. If this 10 Act does not receive the vote necessary for immediate effect, this 11 Act takes effect September 1, 2023.
