12 SECTION 10. Not later than January 1, 2024, the Texas 13 Commission of Licensing and Regulation shall adopt rules to 14 implement the changes in law made by this Act to Chapters 1901 and 15 1902, Occupations Code.

16 SECTION 11. Sections 1901.155 and 1902.155, Occupations 17 Code, as amended by this Act, apply only to a license issued under Chapter 1901 or 1902, Occupations Code, that expires on or after 18 January 1, 2024. A license issued under Chapter 1901 or 1902, 19 Occupations Code, that expires before January 1, 2024, is governed 20 by the law in effect immediately before the effective date of this 21 Act, and the former law is continued in effect for that purpose. 22 SECTION 12. This Act takes effect September 1, 2023. 23
