9	Border Security Advisory Council is a permanent special advisory
10	committee created to advise the legislature and the governor or the
11	governor's designee on homeland security issues impacting the
12	security of the Texas-Mexico border and on streamlining statewide
13	border security activities and initiatives.
14	(b) The council is composed of:
15	(1) the lieutenant governor;
16	(2) the speaker of the house of representatives;
17	(3) four senators appointed by the lieutenant governor
18	who collectively meet the following requirements:
19	(A) two senators must be members of the political
20	party with the most members in the senate and two senators must be

members of the political party with the second most members in the

1	(C) one senator must be the chair of the senate
2	standing committee with primary jurisdiction over border security
3	issues;
4	(4) four members of the house of representatives
5	appointed by the speaker of the house of representatives who
6	collectively meet the following requirements:
7	(A) two representatives must be members of the
8	political party with the most members in the house and two
9	representatives must be members of the political party with the
10	second most members in the house;
11	(B) two representatives must represent house
12	districts located in the border region; and
13	(C) one representative must be the chair of the
14	house standing committee with primary jurisdiction over border
15	security issues;
16	(5) as nonvoting members, the executive head of or a
17	designee from each of the following:
18	(A) Department of Public Safety;
19	(B) Texas Military Department;
20	(C) Texas Division of Emergency Management;
21	(D) Parks and Wildlife Department;
22	(E) Texas Department of Criminal Justice; and
23	(F) Office of Court Administration of the Texas
24	Judicial System;
25	(6) the following nonvoting members appointed by the
26	governor or the governor's designee:
27	(A) one representative of a county located in the

- 1 border region, other than a sheriff;
- 2 (B) one sheriff of a county located in the border
- 3 region;
- 4 (C) one representative of a municipality located
- 5 <u>in the border region, other than a municipal police chief;</u>
- 6 (D) one police chief of a municipality located in
- 7 the border region; and
- 8 (E) one representative of the business community
- 9 involved in international trade across the Texas-Mexico border; and
- 10 (7) other nonvoting members as determined by the
- 11 governor or the governor's designee.
- 12 <u>(c) The lieutenant governor and the speaker of the house of</u>
- 13 representatives are joint chairs of the council.
- 14 (d) A majority of the voting members of the council
- 15 constitutes a quorum to transact business. If a quorum is present,
- 16 the council may act on any matter within the council's jurisdiction
- 17 by a majority vote.
- 18 (e) The council shall meet as often as necessary to perform
- 19 the council's duties. Meetings may be held at any time at the
- 20 request of either chair.
- 21 (f) As an exception to Chapter 551 and other law, for a
- 22 meeting at which both joint chairs of the council are physically
- 23 present, any number of the other council members may attend the
- 24 meeting by use of telephone conference call, video conference call,
- 25 or other similar technology. This subsection applies for purposes
- 26 of establishing a quorum or voting or for any other purpose allowing
- 27 the members to fully participate in any council meeting. This

- 1 subsection applies without regard to the subject or topics
- 2 considered by the members at the meeting.
- 3 (g) A council meeting held by use of telephone conference
- 4 <u>call</u>, video conference call, or other similar technology:
- 5 (1) is subject to the notice requirements applicable
- 6 to other meetings;
- 7 (2) must specify in the notice of the meeting the
- 8 location at which the joint chairs will be physically present;
- 9 (3) must be open to the public and audible to the
- 10 public at the location specified in the notice under Subdivision
- 11 (2); and
- 12 (4) must provide two-way audio communication between
- 13 <u>all council members attending the meeting during the entire</u>
- 14 meeting, and if the two-way audio communication link with any
- 15 member attending the meeting is disrupted at any time, the meeting
- 16 may not continue until the two-way audio communication link is
- 17 reestablished.
- 18 (h) In addition to the duties under Section 421.045, the
- 19 council shall:
- 20 (1) use statistical analyses and other research
- 21 methods to conduct an in-depth examination of border safety
- 22 initiatives and programs in this state that includes:
- (A) an assessment of the cost-effectiveness of
- 24 the use of state and local funds in ensuring border safety;
- 25 (B) an identification of critical border safety
- 26 problems; and
- (C) a determination of the state's long-range

2	(2) recommend to the legislature and the governor:
3	(A) strategies to solve the problems identified

5	(B) policy priorities to address the long-range

9	(3) advise the legislature and the governor regarding:

18	(4) advise and assist the legislature and the governor

21	(i) The council may hire staff or may contract with
22	universities or other suitable entities to assist the council in
23	carrying out the council's duties. Funding to support the
24	operation of the council shall be provided from funds appropriated
25	to the Texas Legislative Council.
26	(j) Not later than January 1 of each odd-numbered year, the
27	council shall submit to the legislature and the governor a report

- 4 Sec. 425.002. BORDER SECURITY ADVISORY COUNCIL TO RECOMMEND
- 5 STATE AGENCY FOR BORDER PROTECTION TASK FORCE. (a) The Border
- 6 Security Advisory Council established under Section 421.0425 shall
- 7 provide to the governor a list of recommendations for the state
- 8 agency that will establish the Border Protection Task Force.
- 9 (b) The governor shall select from the list under Subsection
- 10 (a) the state agency that will establish the Border Protection Task
- 11 Force.
- 12 Sec. 425.003. BORDER PROTECTION TASK FORCE ESTABLISHED.

- 21 and operations of the task force, including homeland security
- 22 strategies, to be administered by the task force and state agencies

- 7 of the governing body, may appoint deputy chiefs and regional
- 8 commanders to oversee the regional offices authorized by Section

- Sec. 425.054. OFFICERS AND OTHER EMPLOYEES. (a) The chief
- 11 may commission, with the approval of the governing body, officers
- 12 of the task force as peace officers.
- (b) The chief may hire any employees as necessary to carry
- 14 out the duties of the task force.
- Sec. 425.055. QUALIFICATIONS. (a) To be a commissioned
- 16 officer of the task force, a person must hold or obtain a peace
- 17 officer license under Chapter 1701, Occupations Code.
- 18 (b) To be a noncommissioned officer of the task force, a
- 19 person must meet the qualifications set by the chief by rule.
- 20 (c) The chief may provide by rule for the qualifications of
- 21 any other employees of the task force.
- 22 (d) The task force is an equal employment opportunity
- 23 employer, and the task force may not discriminate against or give
- 24 preferential treatment to any employee or job applicant on account

- 2 administrative duties of the task force, including land, air, and
- 3 maritime responsibilities. The task force shall conduct the
- 4 training in the border region.
- 5 Sec. 425.057. AUTHORITY OF DEDICATED PERSONNEL. (a) A
- 6 person dedicated to the task force and its duties under Section
- 7 425.006 or 425.007 retains the authority of the office held by the
- 8 person with the dedicating state agency or local government and may
- 9 exercise any powers granted to the task force under this chapter
- 10 with the approval of the chief.
- 11 (b) The governing body, with the approval of the governor,
- 12 may assign the person additional duties consistent with the duties
- 13 of the task force under this chapter.
- 14 Sec. 425.058. USE OF DEDICATED PROPERTY. Any property,
- 15 including equipment or facilities, dedicated to the task force and
- 16 its duties under Section 425.006 or 425.007 may be used for the
- 17 purposes of the dedicating state agency or local government or the
- 18 purposes of the task force.
- 19 ARTICLE 3. EFFECTIVE DATE
- 20 SECTION 3.01. This Act takes effect immediately if it
- 21 receives a vote of two-thirds of all the members elected to each
- 22 house, as provided by Section 39, Article III, Texas Constitution.
- 23 If this Act does not receive the vote necessary for immediate
- 24 effect, this Act takes effect September 1, 2023.
