- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 119A.003, Health and Safety Code, is
- 6 amended by amending Subsection (a) and adding Subsection (d) to
- 7 read as follows:
- 8 (a) The advisory council is composed of the following 19
- 9 members:
- 10 (1) one member designated by the executive
- 11 commissioner;
- 12 (2) two members of the senate appointed by the
- 13 lieutenant governor;
- 14 (3) two members of the house of representatives
- 15 appointed by the speaker of the house of representatives; and
- 16 (4) 14 members appointed by the governor with the
- 17 following qualifications:
- 18 (A) three members who are health care providers,
- 19 as defined by Section 161.201;
- 20 <u>(B)</u> one member who is a licensed health care
- 21 provider with expertise in treating persons with pediatric
- 22 acute-onset neuropsychiatric syndrome, including pediatric
- 23 autoimmune neuropsychiatric disorders associated with
- 24 streptococcal infections, and autism;

- 24 (a)(2) or (3) may designate another individual to serve in the
- 25 member's place on the advisory council at the pleasure of the
- 26 member. An advisory council member who designates another
- 27 individual to serve in the member's place under this subsection

- 1 shall provide written notification to the chair of the advisory
- 2 council.
- 3 SECTION 2. Section 119A.005, Health and Safety Code, is
- 4 amended to read as follows:
- 5 Sec. 119A.005. CHAIR AND VICE CHAIR. Members of the
- 6 advisory council shall elect from among its [the legislative]
- 7 members by a majority vote [of the advisory council] a chair and
- 8 vice chair.
- 9 SECTION 3. This Act takes effect September 1, 2023.
