1 AN ACT 2 relating to the administration of a local anesthetic agent by a 3 dental hygienist. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 258.001, Occupations Code, is amended to read as follows: 6 Sec. 258.001. IMPERMISSIBLE DELEGATIONS. A dentist may not 7 delegate: 8 an act to an individual who, by board order, is 9 (1)prohibited from performing the act; 10 11 (2) any of the following acts to a person not licensed 12 as a dentist or dental hygienist: 13 (A) the removal of calculus, deposits, or accretions from the natural and restored surfaces of exposed human 14 teeth and restorations in the human mouth; 15 (B) root planing or the smoothing and polishing 16 of roughened root surfaces or exposed human teeth; or 17 18 (C) any other act the delegation of which is prohibited by board rule; 19 20 any of the following acts to a person not licensed (3) 21 as a dentist: 22 (A) comprehensive examination or diagnosis and 23 treatment planning; a surgical or cutting procedure on hard or 24 (B)

No. 3824 1 soft tissue; (C) the prescription of a drug, medication, or 2 3 work authorization; 4 (D) the taking of an impression for a final 5 restoration, appliance, or prosthesis; 6 (E) the intraoral making of an occlusal 7 adjustment; 8 (F) direct pulp capping, pulpotomy, or any other endodontic procedure; 9 10 (G) the final placement and intraoral adjustment of a fixed or removable appliance; or 11 the placement of any final restoration; [or] 12 (H) (4) the authority to an individual to administer a 13 14 local anesthetic agent, inhalation sedative agent, parenteral 15 sedative agent, or general anesthetic agent, including as a teledentistry dental service as that term is defined by Section 16 17 111.001, if the individual is not licensed as: a dentist with a permit issued by the board 18 (A) for the procedure being performed, if a permit is required; 19 20 (B) a certified registered nurse anesthetist 21 licensed by the Texas Board of Nursing, only if the delegating dentist holds a permit issued by the board for the procedure being 22 23 performed, if a permit is required; or 24 (C) a physician anesthesiologist licensed by the 25 Texas Medical Board; or 26 (5) the authority to a dental hygienist to administer 27 a local anesthetic agent unless:

5	SECTION 2. Section 262.002(a), Occupations Code, is amended
6	to read as follows:
7	(a) A person practices dental hygiene if the person:
8	(1) removes accumulated matter, tartar, deposits,
9	accretions, or stains, other than mottled enamel stains, from the
10	natural and restored surface of exposed human teeth and
11	restorations in the human mouth;
12	(2) smoothes roughened root surfaces;
13	(3) polishes exposed human teeth, restorations in the
14	human mouth, or roughened root surfaces;
15	(4) topically applies drugs to the surface tissues of
16	the human mouth or the exposed surface of human teeth;
17	(5) makes dental x-rays; [and]
18	(6) <u>administers a local anesthetic agent under the</u>
19	authorization and supervision of a dentist in compliance with
20	Section 258.001(5); and
21	(7) performs any other service, task, or procedure
22	prescribed by board rule.
23	SECTION 3. (a) Not later than January 1, 2024, the State
24	Board of Dental Examiners shall:
25	(1) prescribe by rule the requirements for a course to
26	train dental hygienists to administer a local anesthetic agent
27	consistent with Section 258.001, Occupations Code, as amended by

1 this Act;

2 (2) develop a procedure for the approval of courses
3 described by Subdivision (1) of this subsection; and

4 (3) adopt rules to administer Sections 258.001 and 5 262.002, Occupations Code, as amended by this Act, including rules 6 to establish the minimum standards for the administration of a 7 local anesthetic agent by a dental hygienist consistent with those 8 sections.

9 (b) A rule adopted under Subsection (a)(1) of this section 10 must require that a course be offered in a classroom setting at an 11 educational institution accredited by the Commission on Dental 12 Accreditation of the American Dental Association.

13 SECTION 4. This Act takes effect September 1, 2023.
