- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

- 14 <u>(A)</u> an interest that is a severed mineral

- 17 property that holds a mortgage on the property that is otherwise
- 18 required to be reported in the statement.
