- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Section 31.031, Tax Code, is
- 6 amended to read as follows:
- 7 Sec. 31.031. INSTALLMENT PAYMENTS OF <u>RESIDENCE</u> [<u>CERTAIN</u>]
- 8 HOMESTEAD TAXES.
- 9 SECTION 2. Sections 31.031(a-1) and (a-2), Tax Code, are
- 10 amended to read as follows:
- 11 (a-1) An individual [to whom this section applies] may pay a
- 12 taxing unit's taxes imposed on property that the person owns and
- 13 occupies as a residence homestead in four equal installments
- 14 without penalty or interest if the first installment is paid before
- 15 the delinquency date and is accompanied by notice to the taxing unit
- 16 that the person will pay the remaining taxes in three equal
- 17 installments. If the delinquency date is February 1, the second
- 18 installment must be paid before April 1, the third installment must
- 19 be paid before June 1, and the fourth installment must be paid
- 20 before August 1. If the delinquency date is a date other than
- 21 February 1, the second installment must be paid before the first day
- 22 of the second month after the delinquency date, the third
- 23 installment must be paid before the first day of the fourth month
- 24 after the delinquency date, and the fourth installment must be paid

- 1 before the first day of the sixth month after the delinquency date.
- 2 (a-2) Notwithstanding the deadline prescribed by Subsection
- 3 (a-1) for payment of the first installment, an individual $[\mbox{to whom}]$
- 4 this section applies] may pay the taxes in four equal installments
- 5 as provided by Subsection (a-1) if the first installment is paid and
- 6 the required notice is provided before the first day of the first
- 7 month after the delinquency date.
- 8 SECTION 3. Section 31.031(a), Tax Code, is repealed.
- 9 SECTION 4. This Act applies only to ad valorem taxes imposed
- 10 for a tax year beginning on or after the effective date of this Act.
- 11 SECTION 5. This Act takes effect January 1, 2024.
