- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter C, Chapter 572, Local Government
- 6 Code, is amended by adding Sections 572.0585 and 572.0586 to read as
- 7 follows:
- 8 Sec. 572.0585. EMINENT DOMAIN IN CERTAIN COUNTIES. (a) A
- 9 public utility agency has the power of eminent domain to be
- 10 <u>exercised</u> in the manner provided by this section. The public
- 11 utility agency may acquire by condemnation, for the use and benefit
- 12 of the agency, land, easements, and property inside the service
- 13 area of the public utility agency, necessary for water, sanitary
- 14 sewer, storm drainage, or flood drainage or control purposes or for
- 15 any other of its projects or purposes. The public utility agency
- 16 may elect to condemn either the fee simple title or a lesser
- 17 property interest.
- 18 (b) The power of eminent domain shall be exercised in the
- 19 manner provided in Chapter 21, Property Code, except that the
- 20 <u>public utility agency is not required to:</u>
- 21 (1) give bond for appeal or bond for costs in any
- 22 condemnation suit or other suit to which it is a party; or
- 23 (2) deposit more than the amount of any award in any

- 1 (c) The power of eminent domain may not be used for the
- 2 condemnation of land for the purpose of acquiring rights to
- 3 underground water or of water or water rights.
- 4 (d) This section only applies to a public utility agency
- 5 domiciled in a county with a population of more than 1.2 million.
- 6 Sec. 572.0586. EXTENSION OF SERVICES. A public utility
- 7 agency shall hold a public hearing and provide an opportunity for
- 8 public comment before extending service to new customers located
- 9 outside the service <u>area identified in the 10-year capital</u>
- 10 improvements plan adopted in compliance with Chapter 395 that is in
- 11 effect when an application for extension of service is received.
- 12 SECTION 2. Section 572.0585, Local Government Code, as
- 13 added by this Act, takes effect only if this Act receives a
- 14 two-thirds vote of all the members elected to each house.
- 15 SECTION 3. Except as otherwise provided by this Act, this
- 16 Act takes effect immediately if it receives a vote of two-thirds of
- 17 all the members elected to each house, as provided by Section 39,
- 18 Article III, Texas Constitution. If this Act does not receive the
- 19 vote necessary for immediate effect, this Act takes effect
- 20 September 1, 2023.
