 AN ACT

- 2 relating to the confidentiality of certain information maintained
- 3 by state licensing agencies.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 552.1176, Government Code, is amended by
- 6 amending Subsection (a) and adding Subsection (d) to read as
- 7 follows:
- 8 (a) Information that relates to the home or business
- 9 address, place of work, [home] telephone number, electronic mail
- 10 address, social security number, [or] date of birth, driver's
- 11 license number or state identification number, passport number,
- 12 <u>emergency contact information</u>, <u>license application</u>, <u>criminal</u>
- 13 <u>history record information obtained in connection with the issuance</u>
- 14 or renewal of a license, or payment information of a person licensed
- 15 to practice law in this state that is maintained under Chapter 81 is
- 16 confidential and may not be disclosed to the public under this
- 17 chapter if the person to whom the information relates:
- 18 (1) chooses to restrict public access to the
- 19 information; and
- 20 (2) notifies the State Bar of Texas of the person's
- 21 choice, in writing or electronically, on a form provided by the
- 22 state bar.
- 23 (d) Subsection (a) does not make confidential or except from
- 24 required public disclosure the name, state bar identification

- 1 number, membership class, or eligibility to practice law of an
- 2 applicant for a license, a license holder, or a person who
- 3 previously held a license.
- 4 SECTION 2. Subchapter C, Chapter 552, Government Code, is
- 5 amended by adding Section 552.11765 to read as follows:
- 6 Sec. 552.11765. CONFIDENTIALITY OF CERTAIN INFORMATION
- 7 MAINTAINED BY STATE LICENSING AUTHORITY. (a) In this section,
- 8 "license" means a license, certificate, registration, permit, or
- 9 other authorization that:
- 10 (1) is issued by a governmental body described by
- 11 Section 552.003(1)(A)(i); and
- 12 (2) a person must obtain to practice or engage in a
- 13 particular business, occupation, or profession.
- 14 (b) Information maintained by a governmental body described
- 15 by Section 552.003(1)(A)(i) is confidential and excepted from the
- 16 requirements of Section 552.021 if:
- 17 (1) the information relates to the home or business
- 18 address, place of work, telephone number, electronic mail address,
- 19 social security number, date of birth, driver's license or state
- 20 identification number, passport number, emergency contact
- 21 <u>information</u>, license application, criminal history record
- 22 information obtained in connection with the issuance or renewal of
- 23 <u>a license</u>, or payment information of:
- 24 (A) an applicant for a license issued by the
- 25 governmental body;
- 26 (B) a person who holds a license issued by the
- 27 governmental body; or

1 (C) a person who previously held a license issued 2 by the governmental body; and 3 (2) the person to whom the information relates: 4 (A) chooses to restrict public access to the 5 information; and 6 (B) notifies the governmental body of the 7 person's choice, in writing or electronically, on a form provided 8 by the governmental body. 9 (c) A choice made under Subsection (b)(2) remains valid until rescinded in writing or electronically by the person. 10 (d) Subsection (b) does not make confidential or except from 11 required public disclosure the name, license number, or license 12 status of an applicant for a license, a license holder, or a person 13 14 who previously held a license. 15 SECTION 3. The changes in law made by this Act apply only to

a request for public information received by a governmental body,

including the State Bar of Texas, or an officer for public

SECTION 4. This Act takes effect September 1, 2023.

information on or after the effective date of this Act.
