1 AN ACT 2 relating to the preauthorization of medical or health care services by a health maintenance organization or an insurer. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 843.348, Insurance Code, is amended by 5 amending Subsection (g) and adding Subsection (g-1) to read as 6 7 follows: (g) Unless a physician or provider has materially 8 9 misrepresented the proposed health care services or has substantially failed to perform the proposed health care services, 10 if [If] the health maintenance organization has preauthorized 11 12 health care services, the health maintenance organization may not deny or reduce payment to the physician or provider for those 13 services based on: 14 (1) medical necessity or appropriateness of care; or 15 16 (2) eligibility or coverage determinations if the proposed health care service is provided to the enrollee before the 17 31st day after the date the health care service was preauthorized 18 [unless the physician or provider has materially misrepresented the 19 proposed health care services or has substantially failed to 20 perform the proposed health care services]. 21 (g-1) Notwithstanding Section 843.347 or any other law, and 22

- 2 SECTION 2. Section 1301.135, Insurance Code, is amended by
- 3 amending Subsection (f) and adding Subsection (f-1) to read as
- 4 follows:
- 5 (f) Unless a physician or health care provider has

- 7 services or has substantially failed to perform the proposed
- 8 medical or health care services, if [If] an insurer has
- 9 preauthorized medical care or health care services, the insurer may

- 12 (1) medical necessity or appropriateness of care; or
- (2) eligibility or coverage determinations if the

- 20 (f-1) Notwithstanding Section 1301.133 or any other law,

- SECTION 3. The changes in law made by this Act apply only to

- 25 services made on or after January 1, 2024, under a health benefit
- 26 plan delivered, issued for delivery, or renewed on or after that

- 1 services made before January 1, 2024, or on or after January 1,
- 2 2024, under a health benefit plan delivered, issued for delivery,

- 6 SECTION 4. This Act takes effect September 1, 2023.
