- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Section 7.026, Education Code, is
- 6 amended to read as follows:
- 7 Sec. 7.026. DONATIONS FOR USE RELATED TO CARDIOPULMONARY
- 8 RESUSCITATION (CPR) AND AUTOMATED EXTERNAL DEFIBRILLATOR (AED)
- 9 INSTRUCTION.

- SECTION 2. Section 7.026(a), Education Code, is amended to
- 11 read as follows:
- 12 (a) The agency may accept donations, including donations of
- 13 equipment, for use in providing <u>instruction in</u> cardiopulmonary
- 14 resuscitation (CPR) and the use of an automated external
- 15 defibrillator (AED) [instruction] to students. The agency:
- 16 (1) shall distribute the donations to school districts
- 17 for the purpose of providing CPR and AED instruction to students
- 18 under Sections 28.0023 and 29.903; and
- 19 (2) may use a portion of the donations to the extent
- 20 necessary to pay administrative expenses related to the donations.
- 21 SECTION 3. Sections 28.0023(b), (c), (e), and (g),
- 22 Education Code, are amended to read as follows:
- 23 (b) The State Board of Education by rule shall require
- 24 instruction in cardiopulmonary resuscitation and the use of an

- 1 <u>automated external defibrillator</u>, for students in grades 7 through
- 2 12.
- 3 (c) A school district or open-enrollment charter school
- 4 shall provide instruction to students in grades 7 through 12 in
- 5 cardiopulmonary resuscitation and the use of an automated external
- 6 <u>defibrillator</u> in a manner consistent with the requirements of this
- 7 section and State Board of Education rules adopted under this
- 8 section. The instruction may be provided as a part of any course. A
- 9 student shall receive the instruction at least once before
- 10 graduation.
- 11 (e) Cardiopulmonary resuscitation instruction must include
- 12 training in cardiopulmonary resuscitation techniques and the use of
- 13 an automated external defibrillator that has been developed:
- 14 (1) by the American Heart Association or the American
- 15 Red Cross; or
- 16 (2) using nationally recognized, evidence-based
- 17 guidelines for emergency cardiovascular care and incorporating
- 18 psychomotor skills to support the instruction.
- 19 (g) A school district or open-enrollment charter school may
- 20 use emergency medical technicians, paramedics, police officers,
- 21 firefighters, representatives of the American Heart Association or
- 22 the American Red Cross, teachers, other school employees, or other
- 23 similarly qualified individuals to provide instruction and
- 24 training under this section. Instruction provided under this
- 25 section is not required to result in certification in
- 26 cardiopulmonary resuscitation or the use of an automated external
- 27 defibrillator. If instruction is intended to result in

- 1 certification in cardiopulmonary resuscitation or the use of an
- 2 automated external defibrillator, the course instructor must be
- 3 authorized to provide the instruction by the American Heart
- 4 Association, the American Red Cross, or a similar nationally
- 5 recognized association.
- 6 SECTION 4. The heading to Section 29.903, Education Code,
- 7 is amended to read as follows:
- 8 Sec. 29.903. CARDIOPULMONARY RESUSCITATION (CPR) AND
- 9 AUTOMATED EXTERNAL DEFIBRILLATOR (AED) INSTRUCTION; DONATIONS TO
- 10 SCHOOL DISTRICTS FOR USE IN CPR AND AED INSTRUCTION.
- SECTION 5. Sections 29.903(a) and (c), Education Code, are
- 12 amended to read as follows:
- 13 (a) A school district may accept from the agency donations
- 14 the agency receives under Section 7.026 for use in providing
- 15 instruction to students in the principles and techniques of CPR and
- 16 the use of an AED. A district may accept other donations,
- 17 including donations of equipment, for use in providing the
- 18 instruction.
- 19 (c) A district may use resources other than those made
- 20 available under Section 7.026 or this section to provide
- 21 instruction to students in the principles and techniques of CPR \underline{and}
- 22 the use of an AED.
- 23 SECTION 6. This Act applies beginning with the 2023-2024
- 24 school year.
- 25 SECTION 7. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this

- 1 Act does not receive the vote necessary for immediate effect, this
- 2 Act takes effect September 1, 2023.
