4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Article 2.127(d), Code of Criminal Procedure, is
6	amended to read as follows:

- 17 volunteers at a campus of a school district, open-enrollment
- 18 charter school, private school, or public junior college located
- 19 within a municipality;
- 20 (4) the sheriff of the county if the person is employed
- 21 or volunteers at a campus of a school district, open-enrollment
- 22 charter school, private school, or public junior college that is
- 23 not located within a municipality; and
- 24 (5) the chief administrator of any peace officer
- 25 commissioned under Section 37.081 or 51.203, Education Code, if the
- 26 person is employed or volunteers at a school district or public
- 27 junior college that has commissioned a peace officer under either
