4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 32, Human Resources Code,
6	is amended by adding Section 32.0631 to read as follows:
7	Sec. 32.0631. ANNUAL NOTICE TO CERTAIN PROVIDERS REGARDING
8	USE OF MEDICAID IDENTIFICATION NUMBERS WITH RESPECT TO NEWBORN
9	CHILDREN. The commission shall annually provide written notice to
10	each health care provider who regularly provides health care
11	services to Medicaid recipients who are pregnant women or newborn
12	<u>children:</u>
13	(1) reminding the providers that when a newborn child
14	of a Medicaid recipient has not been assigned a Medicaid
15	identification number, the provider may use the recipient's
16	Medicaid identification number on any claim for reimbursement under
17	Medicaid; and
18	(2) encouraging providers to educate Medicaid
19	recipients who are mothers or the prospective mothers of newborn
20	children that the recipient may use the recipient's Medicaid
21	identification number until the recipient's newborn child is
22	enrolled in Medicaid.
23	SECTION 2. Section 161.501(a), Health and Safety Code, is

No. 4476 (a) A hospital, birthing center, physician, nurse midwife, 1 or midwife who provides prenatal care to a pregnant woman during 2 3 gestation or at delivery of an infant shall: 4 (1) provide the woman and the father of the infant, if 5 possible, or another adult caregiver for the infant, with a resource pamphlet that includes: 6 7 a list of the names, addresses, and phone (A) 8 numbers of professional organizations that provide postpartum counseling and assistance to parents relating to postpartum 9 10 depression and other emotional trauma associated with pregnancy and parenting; 11 12 (B) information regarding the prevention of shaken baby syndrome including: 13 14 (i) techniques for coping with anger caused 15 by a crying baby; (ii) different methods for preventing a 16 17 person from shaking a newborn, infant, or other young child; (iii) the dangerous effects of shaking a 18 newborn, infant, or other young child; and 19 (iv) the symptoms of shaken baby syndrome 20 21 and who to contact, as recommended by the American Academy of Pediatrics, if a parent suspects or knows that a baby has been 22 23 shaken in order to receive prompt medical treatment; 24 (C) a list of diseases for which a child is required by state law to be immunized and the appropriate schedule 25 26 for the administration of those immunizations; 27 (D) the appropriate schedule for follow-up

1 procedures for newborn screening; 2 (E) information regarding sudden infant death 3 syndrome, including current recommendations for infant sleeping conditions to lower the risk of sudden infant death syndrome; 4 5 (F) educational information in both English and 6 Spanish on: 7 (i) pertussis disease and the availability 8 of a vaccine to protect against pertussis, including information on the Centers for Disease Control and Prevention recommendation that 9 10 parents receive Tdap during the postpartum period to protect newborns from the transmission of pertussis; and 11 12 (ii) the incidence of cytomegalovirus, birth defects caused by congenital cytomegalovirus, and available 13 14 resources for the family of an infant born with congenital 15 cytomegalovirus; [and] 16 (G) the danger of heatstroke for a child left unattended in a motor vehicle; and 17 18 (H) information about Medicaid benefits for 19 children, including eligibility requirements and the process for applying for those benefits; 20 if the woman is a recipient of medical assistance 21 (2) under Chapter 32, Human Resources Code, provide the woman and the 22 23 father of the infant, if possible, or another adult caregiver with a 24 resource guide that includes information in both English and Spanish relating to the development, health, and safety of a child 25 26 from birth until age five, including information relating to: (A) 27 selecting and interacting with a primary

3 (B) dental care; (C) effective parenting; 4 (D) child safety; 5 the importance of reading to a child; (E) 6 (F) expected developmental milestones; 7 8 (G) health care resources available in the state; 9 selecting appropriate child care; and (H) other resources available in the state; 10 (I)

(3) document in the woman's record that the woman received the resource pamphlet described in Subdivision (1) and the resource guide described in Subdivision (2), if applicable; and

14 (4) retain the documentation for at least five years 15 in the hospital's, birthing center's, physician's, nurse midwife's, 16 or midwife's records.

17 SECTION 3. (a) Not later than December 1, 2023, the 18 Department of State Health Services shall include the information 19 required by Section 161.501(a)(1)(H), Health and Safety Code, as 20 added by this Act, in the informational materials required by that 21 section.

(b) Notwithstanding Section 161.501(a)(1)(H), Health and Safety Code, as added by this Act, a hospital, birthing center, physician, nurse midwife, or midwife who provides prenatal care to a pregnant woman during gestation or at delivery of an infant is not required to comply with that provision until January 1, 2024.

27 SECTION 4. This Act takes effect September 1, 2023.
