1-27 relating to annual financial reports submitted by state agencies.  
 1-28 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:  
 1-29 SECTION 1. Section 2101.011, Government Code, is amended by  
 1-30 amending Subsections (a) and (b) and adding Subsections (b-1) and  
 1-31 (b-2) to read as follows:  
 1-32 (a) In this section:  
 1-33 (1) "Annual financial report" means the annual  
 1-34 financial report required by this section.  
 1-35 (2) "Appropriated money" means money appropriated by  
 1-36 the legislature under the General Appropriations Act or other law.  
 1-37 (3) "Institution of higher education" has the meaning  
 1-38 assigned by Section 61.003, Education Code.  
 1-39 (b) Except as provided by Subsections (b-1) and (b-2), not  
 1-40 ~~later~~ later than November 1 ~~[20]~~ of each year, a state agency shall  
 1-41 submit an annual financial report regarding the agency's use of  
 1-42 appropriated money during the preceding fiscal year to:  
 1-43 (1) the governor;  
 1-44 (2) the comptroller;  
 1-45 (3) the Legislative Reference Library;  
 1-46 (4) the state auditor; and  
 1-47 (5) the Legislative Budget Board.  
 1-48 (b-1) An institution of higher education shall submit the  
 1-49 annual financial report described by Subsection (b) not later than  
 1-50 November 20 of each year.  
 1-51 (b-2) A state agency may submit an audited financial report  
 1-52 in place of the report described by Subsection (b). An audited  
 1-53 financial report must be submitted not later than December 15 of  
 1-54 each year.  
 1-55 SECTION 2. This Act takes effect September 1, 2024.
