6	by adding Chapter 1462 to read as follows:
7	CHAPTER 1462. UNCONDITIONAL DESIGNATION AS PREFERRED PROVIDER
8	Sec. 1462.001. DEFINITIONS. In this chapter:
9	(1) "Managed care plan" means a health benefit plan
10	under which health care services are provided to enrollees through
11	contracts with physicians and that requires enrollees to use
12	participating physicians or that provides a different level of
13	coverage for enrollees who use participating physicians. The term
14	includes a health benefit plan issued by:
15	(A) a health maintenance organization;
16	(B) a preferred provider benefit plan issuer; or
17	(C) any other entity that issues a health benefit
18	plan, including an insurance company.
19	(2) "Participating physician" means a physician who
20	has directly or indirectly contracted with a health benefit plan
21	issuer to provide services to enrollees.
22	(3) "Physician" means an individual licensed to practice
23	medicine in this state. The term does not include an individual
24	holding a license to practice administrative medicine under Section

- 6 SECTION 4. This Act takes effect September 1, 2023.
