- 5 SECTION 5. It is the intent of the 88th Legislature, Regular
- 6 Session, 2023, that the amendments made by this Act be harmonized
- 7 with another Act of the 88th Legislature, Regular Session, 2023,
- 8 relating to nonsubstantive additions to and corrections in enacted
- 9 codes.
- 10 SECTION 6. This Act takes effect September 1, 2023.
