(a) In this section, "institution of higher education" has the meaning assigned 10 by Section 61.003. 11 12 (b) For purposes of certifying the employment of an adjunct or other part-time faculty member for the Public Service Loan 13 14 Forgiveness Program administered by the United States Department of Education only, an institution of higher education shall: 15 16 (1) consider the faculty member to have worked at least 3.35 hours for each credit hour or contact hour of instruction 17 the faculty member provides; and 18 (2) designate the faculty member as a full-time 19 employee if the faculty member works on average at least 30 hours 20 per week based on the number of hours the faculty member is 21 considered to have worked under Subdivision (1). 22 23 (c) Not later than the 60th day after the date an institution of higher education receives a certification and 24

An institution of higher education may deliver a written notice under this section to an employee by 23 24 hand delivery, mail, e-mail, or other form of electronic communication commonly used by the institution to communicate with 25 26 employees.
