5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 8843.056(c), Special District Local Laws

Code, is amended to read as follows:

- 8 (c) When the boundaries of the single-member districts are
- 9 changed [At the first election after the single-member districts
- 10 are revised], a [new] director in office on the effective date of
- 11 the change, or elected or appointed before the effective date of the
- 12 change to a term of office beginning on or after the effective date
- of the change, is entitled to serve the term or the remainder of the
- 14 term in the single-member district to which the director was
- 15 elected or appointed even though the change in boundaries places
- 16 the director's residence outside the single-member district for
- 17 which the director was elected or appointed [shall be elected from
- 18 each district. The directors shall draw lots to determine which two
- 19 directors serve one-year terms and which three directors serve
- 20 two-year terms].
- 21 SECTION 2. Section 8843.055, Special District Local Laws
- 22 Code, is repealed.
- 23 SECTION 3. The selection of terms of the board of directors
- 24 that occurred before the effective date of this Act and in

- 1 accordance with Section 8843.056(c), Special District Local Laws
- 2 Code, is validated and confirmed.
- 3 SECTION 4. The change in law made by this Act applies only
- 4 to a change in the boundaries of the single-member districts from
- 5 which the members of the board of directors of the Hays Trinity
- 6 Groundwater Conservation District are elected that is made on or
- 7 after the effective date of this Act. A change in the boundaries of
- 8 the single-member districts that is made before the effective date
- 9 of this Act is governed by the law as it existed immediately before
- 10 the effective date of this Act, and that law is continued in effect
- 11 for that purpose.
- 12 SECTION 5. (a) The legal notice of the intention to
- 13 introduce this Act, setting forth the general substance of this
- 14 Act, has been published as provided by law, and the notice and a
- 15 copy of this Act have been furnished to all persons, agencies,
- 16 officials, or entities to which they are required to be furnished
- 17 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 18 Government Code.
- 19 (b) The governor, one of the required recipients, has
- 20 submitted the notice and Act to the Texas Commission on
- 21 Environmental Quality.
- (c) The Texas Commission on Environmental Quality has filed
- 23 its recommendations relating to this Act with the governor, the
- 24 lieutenant governor, and the speaker of the house of
- 25 representatives within the required time.
- 26 (d) All requirements of the constitution and laws of this
- 27 state and the rules and procedures of the legislature with respect

- 1 to the notice, introduction, and passage of this  $\mbox{Act}$  are fulfilled
- 2 and accomplished.
- 3 SECTION 6. This Act takes effect September 1, 2023.
