22	Sec. 7969A.0103. CONFIRMATION AND DIRECTOR ELECTION		
23	REQUIRED. The temporary directors shall hold an election to		
24	confirm the creation of the district and to elect five permanent

- 2 Sec. 7969A.0104. CONSENT OF MUNICIPALITY REQUIRED. The
- 3 temporary directors may not hold an election under Section

- 5 extraterritorial jurisdiction the district is located has
- 6 consented by ordinance or resolution to the creation of the
- 7 district and to the inclusion of land in the district.
- 8 Sec. 7969A.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
- 9 (a) The district is created to serve a public purpose and benefit.
- 10 (b) The district is created to accomplish the purposes of:

- 12 general law and Section 59, Article XVI, Texas Constitution; and
- 13 (2) Section 52, Article III, Texas Constitution, that
- 14 relate to the construction, acquisition, improvement, operation,
- 15 or maintenance of macadamized, graveled, or paved roads, or
- 16 improvements, including storm drainage, in aid of those roads.
- 17 Sec. 7969A.0106. INITIAL DISTRICT TERRITORY. (a) The
- 18 district is initially composed of the territory described by
- 19 Section 2 of the Act enacting this chapter.
- 20 (b) The boundaries and field notes contained in Section 2 of
- 21 the Act enacting this chapter form a closure. A mistake made in the
- 22 field notes or in copying the field notes in the legislative process
- 23 <u>does not affect the district's:</u>
- 24 <u>(1) organization, existence, or validity;</u>
- 25 (2) right to issue any type of bond for the purposes
- 26 for which the district is created or to pay the principal of and

TEMPORARY DIRECTORS. (a) On or after September 1, 2023, the owner or owners of a majority of the assessed 9 value of the real property in the district may submit a petition to 10 the commission requesting that the commission appoint as temporary 11 12 directors the five persons named in the petition. The commission shall appoint as temporary directors the five persons named in the 13 14 petition. 15 (b) Temporary directors serve until the earlier of: 16 (1) the date permanent directors are elected under Section 7969A.0103; or 17 18 (2) September 1, 2027. 19 (c) If permanent directors have not been elected under Section 7969A.0103 and the terms of the temporary directors have 20 expired, successor temporary directors shall be appointed or 21 reappointed as provided by Subsection (d) to serve terms that 22 23 expire on the earlier of: 24 (1) the date permanent directors are elected under 25 Section 7969A.0103; or 26 (2) the fourth anniversary of the date of the

- 8 SUBCHAPTER C. POWERS AND DUTIES
- 9 Sec. 7969A.0301. GENERAL POWERS AND DUTIES. The district
- 10 has the powers and duties necessary to accomplish the purposes for
- 11 which the district is created.
- 12 Sec. 7969A.0302. MUNICIPAL UTILITY DISTRICT POWERS AND
- 13 DUTIES. The district has the powers and duties provided by the
- 14 general law of this state, including Chapters 49 and 54, Water Code,
- 15 applicable to municipal utility districts created under Section 59,
- 16 Article XVI, Texas Constitution.
- 17 Sec. 7969A.0303. AUTHORITY FOR ROAD PROJECTS. Under
- 18 <u>Section 52</u>, Article III, Texas Constitution, the district may
- 19 design, acquire, construct, finance, issue bonds for, improve,
- 20 operate, maintain, and convey to this state, a county, or a
- 21 municipality for operation and maintenance macadamized, graveled,
- 22 or paved roads, or improvements, including storm drainage, in aid
- 23 of those roads.
- Sec. 7969A.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A
- 25 road project must meet all applicable construction standards,
- 26 zoning and subdivision requirements, and regulations of each
- 27 municipality in whose corporate limits or extraterritorial

- 1 jurisdiction the road project is located.
- 2 (b) If a road project is not located in the corporate limits
- 3 or extraterritorial jurisdiction of a municipality, the road

- 7 (c) If the state will maintain and operate the road, the

- 10 Sec. 7969A.0305. COMPLIANCE WITH MUNICIPAL CONSENT
- 11 ORDINANCE OR RESOLUTION. The district shall comply with all
- 12 applicable requirements of any ordinance or resolution that is
- 13 adopted under Section 54.016 or 54.0165, Water Code, and that
- 14 consents to the creation of the district or to the inclusion of land
- 15 <u>in the district.</u>
- Sec. 7969A.0306. DIVISION OF DISTRICT. (a) The district
- 17 may be divided into two or more new districts only if the district:
- 18 (1) has no outstanding bonded debt; and
- 19 (2) is not imposing ad valorem taxes.
- 20 (b) This chapter applies to any new district created by the
- 21 division of the district, and a new district has all the powers and
- 22 duties of the district.
- 23 (c) Any new district created by the division of the district
- 24 may not, at the time the new district is created, contain any land
- 25 outside the area described by Section 2 of the Act enacting this
- 26 chapter.
- 27 (d) The board, on its own motion or on receipt of a petition

- 1 signed by the owner or owners of a majority of the assessed value of
- 2 the real property in the district, may adopt an order dividing the

- 4 (e) The board may adopt an order dividing the district

- 13 (4) provide for the division of assets and liabilities
- 14 between or among the new districts.
- 15 (g) On or before the 30th day after the date of adoption of
- 16 an order dividing the district, the district shall file the order
- 17 with the commission and record the order in the real property
- 18 records of each county in which the district is located.
- 19 (h) Any new district created by the division of the district
- 20 shall hold a confirmation and directors' election as required by
- 21 Section 7969A.0103. If the voters of a new district do not confirm
- 22 the creation of the new district, the assets, obligations,
- 23 territory, and governance of the new district revert to the
- 24 original district.
- 25 (i) If the creation of the new district is confirmed, the
- 26 new district shall provide the election date and results to the
- 27 commission.

- 15 (2) contract payments described by Section
- 16 7969A.0403.
- 17 (b) The district must hold an election in the manner
- 18 provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 19 before the district may impose an ad valorem tax or issue bonds
- 20 payable from ad valorem taxes.
- 21 <u>(c)</u> The district may not issue bonds payable from ad valorem
- 22 taxes to finance a road project unless the issuance is approved by a

- 24 election held for that purpose.
- Sec. 7969A.0402. OPERATION AND MAINTENANCE TAX. (a) If
- 26 authorized at an election held under Section 7969A.0401, the
- 27 district may impose an operation and maintenance tax on taxable

- 1 property in the district in accordance with Section 49.107, Water
- 2 Code.
- 3 (b) The board shall determine the tax rate. The rate may not
- 4 exceed the rate approved at the election.
- 5 Sec. 7969A.0403. CONTRACT TAXES. (a) In accordance with
- 6 Section 49.108, Water Code, the district may impose a tax other than
- 7 an operation and maintenance tax and use the revenue derived from
- 8 the tax to make payments under a contract after the provisions of
- 9 the contract have been approved by a majority of the district voters

- 25 or part of the bonds are outstanding as required and in the manner
- 26 provided by Sections 54.601 and 54.602, Water Code.
- Sec. 7969A.0503. BONDS FOR ROAD PROJECTS. At the time of
