A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Tarrant County Municipal Utility
3	District No. 2; granting a limited power of eminent domain;
4	providing authority to issue bonds; providing authority to impose
5	assessments, fees, and taxes.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle F, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 8092 to read as follows:
9	CHAPTER 8092. TARRANT COUNTY MUNICIPAL UTILITY DISTRICT NO. 2
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8092.0101. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Commission" means the Texas Commission on
14	Environmental Quality.
15	(3) "Director" means a board member.
16	(4) "District" means the Tarrant County Municipal
17	<pre>Utility District No. 2.</pre>
18	Sec. 8092.0102. NATURE OF DISTRICT. The district is a
19	municipal utility district created under Section 59, Article XVI,
20	Texas Constitution.
21	Sec. 8092.0103. CONFIRMATION AND DIRECTOR ELECTION
22	REQUIRED. The temporary directors shall hold an election to
23	confirm the creation of the district and to elect five permanent
24	directors as provided by Section 49.102, Water Code.

- Sec. 8092.0104. CONSENT OF MUNICIPALITY REQUIRED. 1 2 temporary directors may not hold an election under Section 8092.0103 until each municipality in whose corporate limits or 3 extraterritorial jurisdiction the district is located has 4 consented by ordinance or resolution to the creation of the 5 district and to the inclusion of land in the district. 6 Sec. 8092.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. 7 8 (a) The district is created to serve a public purpose and benefit. 9 (b) The district is created to accomplish the purposes of: (1) a municipal utility district as provided by 10 general law and Section 59, Article XVI, Texas Constitution; and 11 12 (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, 13 or maintenance of macadamized, graveled, or paved roads, or 14 15 improvements, including storm drainage, in aid of those roads. Sec. 8092.0106. INITIAL DISTRICT TERRITORY. (a) The 16 17 district is initially composed of the territory described by Section 2 of the Act enacting this chapter. 18 19 (b) The boundaries and field notes contained in Section 2 of the Act enacting this chapter form a closure. A mistake made in the 20 field notes or in copying the field notes in the legislative process 21 22 does not affect the district's: 23 (1) organization, existence, or validity;
 - (3) right to impose a tax; or

interest on a bond;

for which the district is created or to pay the principal of and

(2) right to issue any type of bond for the purposes

1	(4) legality or operation.
2	SUBCHAPTER B. BOARD OF DIRECTORS
3	Sec. 8092.0201. GOVERNING BODY; TERMS. (a) The district is
4	governed by a board of five elected directors.
5	(b) Except as provided by Section 8092.0202, directors
6	serve staggered four-year terms.
7	Sec. 8092.0202. TEMPORARY DIRECTORS. (a) The temporary
8	<pre>board consists of:</pre>
9	(1) William Christopher Vertin;
10	(2) Mattison Margaret Raiford;
11	(3) Crystal Maddalena;
12	(4) Parker Morgan; and
13	(5) Mitchell Henton.
14	(b) Temporary directors serve until the earlier of:
15	(1) the date permanent directors are elected under
16	<u>Section 8092.0103; or</u>
17	(2) the fourth anniversary of the effective date of
18	the Act enacting this chapter.
19	(c) If permanent directors have not been elected under
20	Section 8092.0103 and the terms of the temporary directors have
21	expired, successor temporary directors shall be appointed or
22	reappointed as provided by Subsection (d) to serve terms that
23	<pre>expire on the earlier of:</pre>
24	(1) the date permanent directors are elected under
25	<u>Section 8092.0103; or</u>
26	(2) the fourth anniversary of the date of the
27	appointment or reappointment.

- 1 <u>(d) If Subsection (c) applies, the owner or owners of a</u>
- 2 majority of the assessed value of the real property in the district
- 3 may submit a petition to the commission requesting that the
- 4 commission appoint as successor temporary directors the five
- 5 persons named in the petition. The commission shall appoint as
- 6 successor temporary directors the five persons named in the
- 7 petition.
- 8 SUBCHAPTER C. POWERS AND DUTIES
- 9 Sec. 8092.0301. GENERAL POWERS AND DUTIES. The district
- 10 has the powers and duties necessary to accomplish the purposes for
- 11 which the district is created.
- 12 Sec. 8092.0302. MUNICIPAL UTILITY DISTRICT POWERS AND
- 13 DUTIES. The district has the powers and duties provided by the
- 14 general law of this state, including Chapters 49 and 54, Water Code,
- 15 applicable to municipal utility districts created under Section 59,
- 16 Article XVI, Texas Constitution.
- 17 Sec. 8092.0303. AUTHORITY FOR ROAD PROJECTS. Under Section
- 18 52, Article III, Texas Constitution, the district may design,
- 19 acquire, construct, finance, issue bonds for, improve, operate,
- 20 maintain, and convey to this state, a county, or a municipality for
- 21 operation and maintenance macadamized, graveled, or paved roads, or
- 22 improvements, including storm drainage, in aid of those roads.
- Sec. 8092.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A
- 24 road project must meet all applicable construction standards,
- 25 zoning and subdivision requirements, and regulations of each
- 26 municipality in whose corporate limits or extraterritorial
- 27 jurisdiction the road project is located.

- 1 (b) If a road project is not located in the corporate limits
- 2 or extraterritorial jurisdiction of a municipality, the road
- 3 project must meet all applicable construction standards,
- 4 subdivision requirements, and regulations of each county in which
- 5 the road project is located.
- 6 (c) If the state will maintain and operate the road, the
- 7 Texas Transportation Commission must approve the plans and
- 8 specifications of the road project.
- 9 Sec. 8092.0305. COMPLIANCE WITH MUNICIPAL CONSENT
- 10 ORDINANCE OR RESOLUTION. The district shall comply with all
- 11 applicable requirements of any ordinance or resolution that is
- 12 adopted under Section 54.016 or 54.0165, Water Code, and that
- 13 consents to the creation of the district or to the inclusion of land
- 14 in the district.
- Sec. 8092.0306. DIVISION OF DISTRICT. (a) The district may
- 16 <u>be divided into two or more new districts only if the district:</u>
- 17 (1) has no outstanding bonded debt; and
- 18 (2) is not imposing ad valorem taxes.
- 19 (b) This chapter applies to any new district created by the
- 20 division of the district, and a new district has all the powers and
- 21 <u>duties of the district.</u>
- (c) Any new district created by the division of the district
- 23 may not, at the time the new district is created, contain any land
- 24 outside the area described by Section 2 of the Act enacting this
- 25 chapter.
- 26 (d) The board, on its own motion or on receipt of a petition
- 27 signed by the owner or owners of a majority of the assessed value of

- 1 the real property in the district, may adopt an order dividing the
- 2 district.
- 3 (e) The board may adopt an order dividing the district
- 4 before or after the date the board holds an election under Section
- 5 8092.0103 to confirm the district's creation.
- 6 (f) An order dividing the district shall:
- 7 (1) name each new district;
- 8 (2) include the metes and bounds description of the
- 9 territory of each new district;
- 10 (3) appoint temporary directors for each new district;
- 11 and
- 12 (4) provide for the division of assets and liabilities
- 13 between or among the new districts.
- 14 (g) On or before the 30th day after the date of adoption of
- 15 an order dividing the district, the district shall file the order
- 16 with the commission and record the order in the real property
- 17 records of each county in which the district is located.
- 18 (h) Any new district created by the division of the district
- 19 shall hold a confirmation and directors' election as required by
- 20 Section 8092.0103. If the voters of a new district do not confirm
- 21 the creation of the new district, the assets, obligations,
- 22 territory, and governance of the new district revert to the
- 23 original district.
- (i) If the creation of the new district is confirmed, the
- 25 new district shall provide the election date and results to the
- 26 comm<u>ission.</u>
- 27 (j) Municipal consent to the creation of the district and to

- 1 the inclusion of land in the district granted under Section
- 2 8092.0104 acts as municipal consent to the creation of any new
- 3 district created by the division of the district and to the
- 4 inclusion of land in the new district.
- 5 (k) Any new district created by the division of the district
- 6 must hold an election as required by this chapter to obtain voter
- 7 approval before the district may impose a maintenance tax or issue
- 8 bonds payable wholly or partly from ad valorem taxes.
- 9 <u>SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS</u>
- Sec. 8092.0401. ELECTIONS REGARDING TAXES OR BONDS. (a)
- 11 The district may issue, without an election, bonds and other
- 12 obligations secured by:
- 13 (1) revenue other than ad valorem taxes; or
- 14 (2) contract payments described by Section 8092.0403.
- 15 (b) The district must hold an election in the manner
- 16 provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 17 before the district may impose an ad valorem tax or issue bonds
- 18 payable from ad valorem taxes.
- 19 (c) The district may not issue bonds payable from ad valorem
- 20 taxes to finance a road project unless the issuance is approved by a
- 21 vote of a two-thirds majority of the district voters voting at an
- 22 election held for that purpose.
- Sec. 8092.0402. OPERATION AND MAINTENANCE TAX. (a) If
- 24 authorized at an election held under Section 8092.0401, the
- 25 district may impose an operation and maintenance tax on taxable
- 26 property in the district in accordance with Section 49.107, Water
- 27 Code.

- 1 (b) The board shall determine the tax rate. The rate may not
- 2 exceed the rate approved at the election.
- 3 Sec. 8092.0403. CONTRACT TAXES. (a) In accordance with
- 4 Section 49.108, Water Code, the district may impose a tax other than
- 5 an operation and maintenance tax and use the revenue derived from
- 6 the tax to make payments under a contract after the provisions of
- 7 the contract have been approved by a majority of the district voters
- 8 voting at an election held for that purpose.
- 9 (b) A contract approved by the district voters may contain a
- 10 provision stating that the contract may be modified or amended by
- 11 the board without further voter approval.
- 12 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
- Sec. 8092.0501. AUTHORITY TO ISSUE BONDS AND OTHER
- 14 OBLIGATIONS. The district may issue bonds or other obligations
- 15 payable wholly or partly from ad valorem taxes, impact fees,
- 16 revenue, contract payments, grants, or other district money, or any
- 17 combination of those sources, to pay for any authorized district
- 18 purpose.
- 19 Sec. 8092.0502. TAXES FOR BONDS. At the time the district
- 20 issues bonds payable wholly or partly from ad valorem taxes, the
- 21 board shall provide for the annual imposition of a continuing
- 22 direct ad valorem tax, without limit as to rate or amount, while all
- 23 or part of the bonds are outstanding as required and in the manner
- 24 provided by Sections 54.601 and 54.602, Water Code.
- Sec. 8092.0503. BONDS FOR ROAD PROJECTS. At the time of
- 26 issuance, the total principal amount of bonds or other obligations
- 27 issued or incurred to finance road projects and payable from ad

- 1 valorem taxes may not exceed one-fourth of the assessed value of the
- 2 real property in the district.
- 3 SECTION 2. The Tarrant County Municipal Utility District
