20	REQUIRED. (a) The temporary directors shall hold an election to		
21	confirm the creation of the district and to elect five permanent		
22	directors as provided by Section 49.102, Water Code.		
23	(b) If the creation of the district is not confirmed and		
24	permanent directors are not elected under this section before

- 1 September 1, 2027, the district shall be dissolved in accordance

- 3 Sec. 6608.0104. CONSENT OF MUNICIPALITY REQUIRED. The
- 4 temporary directors may not hold an election under Section
- 5 6608.0103 until each municipality in whose corporate limits or
- 6 extraterritorial jurisdiction the district is located has
- 7 consented by ordinance or resolution to the creation of the
- 8 district and to the inclusion of land in the district.
- 9 Sec. 6608.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
- 10 (a) The district is created to serve a public purpose and benefit.
- 11 (b) The district is created to accomplish the purposes of:
- 12 (1) a conservation and reclamation district as
- 13 provided by general law and Section 59, Article XVI, Texas
- 14 Constitution; and
- 15 (2) Section 52, Article III, Texas Constitution, that
- 16 relate to the construction and maintenance of pools, lakes,
- 17 reservoirs, dams, canals, and waterways for the purposes of
- 18 irrigation, drainage, or navigation.
- 19 Sec. 6608.0106. INITIAL DISTRICT TERRITORY. (a) The

- 5 Sec. 6608.0301. GENERAL POWERS AND DUTIES. The district
- 6 has the powers and duties necessary to accomplish the purposes for
- 7 which the district is created.
- 8 Sec. 6608.0302. WATER CONTROL AND IMPROVEMENT DISTRICT
- 9 POWERS AND DUTIES. (a) The district has the powers and duties
- 10 provided by the general law of this state, including Chapters 49 and
- 11 51, Water Code, applicable to water control and improvement
- 12 districts created under Section 59, Article XVI, Texas
- 13 Constitution.
- 14 (b) The district may seek and use grants, gifts, donations,
- or money from other stormwater or drainage programs.
- 16 (c) The district may not issue bonds or impose a tax, fee, or
- 17 assessment under Chapter 49 or 51, Water Code.
- 18 Sec. 6608.0303. NO EMINENT DOMAIN POWER. The district may
- 19 not exercise the power of eminent domain.
- 20 SUBCHAPTER D. DISSOLUTION
- Sec. 6608.0401. DISSOLUTION. (a) If permanent directors
- 22 have not been elected under Section 6608.0103 by September 1, 2027,
- 23 the district is dissolved.
- (b) On dissolution of the district, the board shall transfer
- 25 <u>all assets, contractual rights, and obligations of the district to</u>
- 26 the Harris County Flood Control District.

- 7 SECTION 3. (a) The legal notice of the intention to

- 10 copy of this Act have been furnished to all persons, agencies,
- 11 officials, or entities to which they are required to be furnished
- 12 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 13 Government Code.
- 14 (b) The governor, one of the required recipients, has
- 15 submitted the notice and Act to the Texas Commission on
- 16 Environmental Quality.
- 17 (c) The Texas Commission on Environmental Quality has filed
- 18 its recommendations relating to this Act with the governor, the
- 19 lieutenant governor, and the speaker of the house of
- 20 representatives within the required time.
- 21 (d) All requirements of the constitution and laws of this
- 22 state and the rules and procedures of the legislature with respect
- 23 to the notice, introduction, and passage of this Act are fulfilled
- 24 and accomplished.
- 25 SECTION 4. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this

- 1 Act does not receive the vote necessary for immediate effect, this
- 2 Act takes effect September 1, 2023.
