A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the Harris County Flood Control District and the
- 3 transfer to it of the assets, programs, and facilities of the Harris
- 4 County Toll Road Authority; providing for the appointment of the
- 5 governing body.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Chapter 360, Acts of the 45th Legislature,
- 8 Regular Session, 1937, is amended by amending Sections 1, 2, 2A, 3,
- 9 4, 5, 6, 7, 8, 9, 10, 11, 12, 12-a, and 12-b and adding Sections 1A,
- 10 1B, 1C, and 12-c to read as follows:
- 11 Sec. 1. Gulf Coast Resiliency [Harris County Flood Control]
- 12 District Created. There is hereby created and established within
- 13 the State of Texas, in addition to the districts into which the
- 14 State has heretofore been divided, in the form and manner
- 15 hereinafter provided, a conservation and reclamation district to be
- 16 known as the Gulf Coast Resiliency [Harris County Flood Control]
- 17 District, hereinafter called the District[, and consisting of that
- 18 part of the State of Texas which is known as and included within the
- 19 boundaries of the County of Harris]. Such District shall be a
- 20 governmental agency and body politic and corporate, with the powers
- 21 of government and with the authority to exercise the rights,
- 22 privileges, and functions hereinafter specified, the creation and
- 23 establishment of such District being essential to the
- 24 accomplishment of the purposes of Section 59 of Article XVI of the

- 1 Constitution of the State of Texas, as amended, including the
- 2 control, storing, preservation, and distribution of the storm and
- 3 flood waters, and the waters of the rivers and streams within the
- 4 bounds of the District [in Harris County] and their tributaries,
- 5 for domestic, municipal, flood control, irrigation, and other
- 6 useful purposes, the reclamation and drainage of the overflow land
- 7 within the bounds of the District [of Harris County], the
- 8 conservation of forests, and to aid in the protection of navigation
- 9 on the navigable waters by regulating the flood and storm waters
- 10 that flow into said navigable streams.
- The District is created to accomplish the purposes of Section
- 12 52, Article <u>III, Texas Constitution</u>, that relate to the
- 13 construction, acquisition, improvement, operation, or maintenance
- 14 of macadamized, graveled, or paved roads, or improvements,
- 15 including storm drainage, in aid of those roads. [The Commissioners
- 16 Court of Harris County, Texas, is hereby designated as the
- 17 governing body of such District and the agency through which the
- 18 management and control of the District shall be administered, and
- 19 it is hereby empowered to do any and all things necessary to carry
- 20 out the aims and purposes of this Act.
- 21 Sec. 1A. DEFINITIONS. In this Act:
- (1) "Board" means the governing body of the District.
- 23 (2) "District" means the Gulf Coast Resiliency
- 24 District.
- 25 (3) "Presiding officer" means the presiding officer of
- 26 the Board.
- 27 (4) "Secretary" means the secretary of the Board.

- 1 (5) "Treasurer" means the treasurer of the Board.
- 2 Sec. 1B. DISTRICT TERRITORY. The boundaries of the
- 3 District are coextensive with the boundaries of Harris County.
- 4 Sec. 1C. BOARD; TERMS. (a) The Board is composed of five
- 5 members who are appointed by the governor with the advice and
- 6 consent of the senate.
- 7 (b) The members of the Board hold office for staggered terms
- 8 of four years, with the terms of two or three members expiring
- 9 January 1 of each odd-numbered year. Each member holds office until
- 10 a successor is appointed and has qualified.
- 11 (c) The governor shall designate one member as the presiding
- 12 officer of the Board to serve at the will of the governor. The Board
- 13 shall elect from among its members a secretary and a treasurer and
- 14 other officers the presiding officer considers necessary.
- 15 (d) A member of the Board may not receive compensation but
- 16 <u>is entitled to reimbursement of the travel expenses incurred by the</u>
- 17 member while conducting the business of the Board.
- 18 Sec. 2. Added Powers. In addition to the powers given to the
- 19 Board [Commissioners Court] by General Laws and in addition to the
- 20 general powers herein given, it shall be authorized in connection
- 21 with the [Harris County Flood Control] District to exercise the
- 22 following added rights, powers, privileges, and functions:
- 23 a. To acquire land and rights and interest therein and any
- 24 other character of property needed to carry on the work of flood
- 25 control, by gift, devise, purchase, or condemnation;
- 26 b. To sell, trade, or otherwise dispose of land or other
- 27 property or rights therein when the same are no longer needed for

- 1 the project or flood control purposes;
- c. To hire [appoint] a flood control manager and other
- 3 [such] agents and employees [of the County] for flood control
- 4 purposes as may be necessary, including an engineer and counsel,
- 5 and to prescribe their duties and fix their bonds and compensation;
- d. To authorize its officers, employees, or agents to go
- 7 upon any lands lying within the District for the purpose of making
- 8 surveys and examining the same in connection with flood control
- 9 plans and projects, and for any other lawful purpose within the
- 10 scope of its authority;
- 11 e. To devise plans and construct works to lessen and control
- 12 floods; to reclaim lands in the District; to prevent the deposit of
- 13 silt in navigable streams; to remove obstructions, natural or
- 14 artificial, from streams and water courses; to regulate the flow of
- 15 surface and flood waters; and to provide drainage where essential
- 16 to the flood control project;
- 17 f. To exercise all powers, rights, privileges, and
- 18 functions conferred by general law upon flood control districts
- 19 created pursuant to Section 59 of Article XVI of the Constitution of
- 20 Texas [, as amended, so far as the same may be applicable to Harris
- 21 County and essential to the flood control project];
- g. To cooperate with and contract with the United States of
- 23 America or with any of its agencies now existing, or which may be
- 24 created hereafter, for grants, loans, or advancements to carry out
- 25 any of the powers or to further any of the purposes set forth in this
- 26 Act and to receive and use said moneys for such purposes; or to
- 27 contribute to the United States of America or any of its agencies in

- 1 connection with any project undertaken by it affecting or relating
- 2 to flood control in the District [Harris County];
- 3 h. To cooperate [with,] or [to] contract with a municipality
- 4 or county within the District, [the City of Houston, or] any
- 5 adjacent county, or any agency or political subdivision of the
- 6 State [or any city or town within Harris County] in relation to
- 7 surveys, the acquisition of land or right of ways, the construction
- 8 or maintenance of projects or parts thereof or the financing of the
- 9 same in connection with any matter within the scope of this Act;
- 10 i. To sue and be sued in any proper case under the laws of
- 11 this State; and all courts shall take judicial notice of the
- 12 establishment of the said District; and
- j. To do any and all other acts or things necessary or proper
- 14 to carry into effect the foregoing powers.
- Sec. 2A. Right to Remove Property. [(a) In this section,
- 16 "district" means the Harris County Flood Control District.
- 17 [(b)] In order to carry out district purposes, the district
- 18 may remove real or personal property placed on land owned by the
- 19 district or land subject to an easement held by the district,
- 20 regardless of when the real or personal property was put in place
- 21 and without the consent of the owner of the property. The district
- 22 must send notice by certified mail to the owner of property on which
- 23 the district intends to act under this section. Not earlier than
- 24 the 30th day after the date the notice is sent, the district must
- 25 send a second notice by certified mail. The district may use
- 26 existing civil lawsuit processes against the owner of the property
- 27 to recover the cost of removing the property not earlier than the

1 30th day after the date the second notice was received.

Sec. 3. Petition for Hearing. A petition may be filed with 2 the Board [County Clerk of Harris County for submission to the 3 Commissioners Court], signed by not less than fifty (50) qualified 4 property taxpaying voters resident of the District [said County] 5 who own and assess property therein, accompanied by the certificate 6 of the Assessor and Collector of Taxes showing that such persons 7 8 have correctly stated the facts with respect to qualifications to sign the petition, which petition may request the 9 10 submission to the qualified voters the question of the issuance of a named amount of bonds for flood control purposes under the 11 provisions of Section 59 of Article XVI of the Constitution of the 12 State of Texas, as amended. Said petition shall set out the general 13 14 nature of the work to be done, the necessity therefor, the 15 feasibility thereof, and a reasonable amount of detail with respect the matters alleged, sufficient to inform the 16 17 [Commissioners Court] fully of the purpose, utility, feasibility, and necessity therefor. The petition shall state the estimated 18 19 cost of the project as then estimated and its operating costs and shall give such additional information as may be available for the 20 purpose. The petition shall request that the Board [Commissioners 21 Court] hear evidence of the feasibility, practicability, and cost 22 23 of the project and whether or not the same would be a public benefit 24 and is needed, and that an election be called to determine whether or not said bonds shall be issued. 25

Sec. 4. Notice of Hearing. Notice of such hearing shall be given by publication once a week for two (2) consecutive weeks prior

1 to the date fixed for such hearing and exclusive thereof in a daily newspaper published in the District [Harris County] which said 2 notice shall consist of a certified copy of the petition and of the 3 order of the Board [Court] setting the same for hearing and shall be 4 signed by the presiding officer [County Judge]. 5 In addition thereto, the Sheriff of each county in the District [Harris County] 6 shall post at least fifteen (15) days prior to the date of hearing, 7 8 one copy of said notice at each of four (4) public places in each county in the District [Harris County] and one copy thereof at the 9 Courthouse door of each county in the District, and said sheriff and 10 the editor of the newspaper in which said notice is published shall 11 make due return under oath showing the dates of posting and 12 publication, respectively. 13 Sec. 5. Hearing. The Board [Commissioners Court] shall

14 15 have jurisdiction to hear, consider, and determine the matters brought before it in said petition and by the evidence produced in 16 17 favor of and against the proposition to issue bonds. The hearing may be continued from day to day. Should the Board [Court] refuse 18 said petition it shall so find and its orders shall be recorded in 19 its minutes refusing said petition and giving its reasons therefor. 20 21 Should the <u>Board</u> [Commissioners Court] determine that proposition to issue such bonds should be submitted at an election 22 23 called for the purpose it shall thereupon enter its order making its 24 findings with respect to the matters herein provided for and shall be authorized to submit in accordance with the provisions of the 25 Constitution and with Subdivisions 1 and 2 of Title 22 of the 26 Revised Civil Statutes of Texas of 1925, to an election of the 27

1 qualified property taxpaying voters resident of the District [said County] who own and assess property therein, the question of a bond 2 3 issue for the purpose of providing said funds, and the District [said County] is given the right, after a majority vote of the 4 5 electors qualified as herein required in favor of the proposition to issue bonds, to issue flood control bonds as authorized by 6 Section 59 of Article XVI of the Constitution of the State of Texas, 7 8 as amended, upon a compliance with the provisions of Subdivisions 1 and 2 of Title 22, Revised Civil Statutes of Texas of 1925, and with 9 10 this Section, and within the limitations therein prescribed; and to levy and assess upon all the property subject to taxation in the 11 12 District [said County], and thereafter to collect such taxes as may annually be required to pay the interest on the bonds voted at said 13 14 election and to create a sinking fund sufficient to retire said bonds at maturity; provided that additional bonds may be issued 15 from time to time in like manner and under the same procedure. 16

17 Provided further, however, that the initial issuance of bonds shall not be for a sum which will require a tax rate in excess of 18 Fifteen (15) Cents on the one hundred dollars valuation on the 19 property within said District, nor shall any subsequent issue of 20 said bonds be authorized the effect of which will be to increase the 21 tax rate for all outstanding bonds of said District including such 22 issue to an amount in excess of Fifteen (15) Cents on the one 23 24 hundred dollars valuation to pay the interest on said bonds and to create a sinking fund to retire the same at maturity. 25

Sec. 6. BOND RECORD. Before any [Harris County Flood Control] District bonds authorized by this Act shall be sold, a

1 certified copy of the proceedings for the issuance thereof

2 including certificates showing the bonded indebtedness of the

3 District, certificates showing the assessed values of the property

4 in [of] the District [County], and certificates reflecting any

5 other information which the Attorney General of the State of Texas

6 may require, shall be submitted to the Attorney General; and if he

7 shall approve such bonds, he shall execute a certificate to that

8 effect, which shall be filed in the office of the Comptroller of

9 Public Accounts of the State of Texas.

provided.

No bonds shall be sold until the same shall have been registered by the Comptroller who shall so register the same if the Attorney General shall have filed with the Comptroller of Public Accounts of the State of Texas his certificate approving the bonds and the proceedings for the issuance thereof, as hereinabove

The [County] Treasurer shall keep a record in a well-bound book of all bonds issued and shall register therein the amount of bonds issued, the numbers, the denomination, rate of interest, date due, date of issue, the paying agent, the amount received, and the purchaser. The said book shall be at all times open to the inspection of all proper parties, either taxpayers or bondholders or officials of the State or County.

When such bonds have been registered with the [County]
Treasurer, the Board [Commissioners Court of said County] shall set
a date for the sale of such amount of bonds as may be needed to
procure funds to construct the improvements then contemplated and
pay the expenses incident thereto, and after advertising said bonds

1 for sale by notice published once a week for two (2) consecutive weeks, shall sell such bonds upon the best terms and for the best 2 price obtainable, but none of said bonds shall be sold for less than the face value thereof and accrued interest thereon to date of 4 5 delivery, and the purchase price of such bonds shall be paid to the [County] Treasurer and shall be by him placed to the credit of the 6 [Harris County Flood Control] District and said funds shall be 7 8 available for the construction of the project and its operation as voted; provided that the accrued interest and premium received 9 10 shall be credited to the interest and sinking fund of the <u>District</u> [County] for such issue of bonds. No commission shall be paid for 11 12 the sale of any bonds.

All bonds approved by the Attorney General, registered by the
Comptroller, and issued and sold in accordance with the proceedings
so approved, shall be valid and binding obligations of the [Harris
County Flood Control] District [of Harris County, Texas,] and shall
be incontestable for any cause from and after the time of such
registration, except for forgery or fraud.

The <u>Board</u> [Commissioners Court] shall have the right to pay all the necessary expenses incident to the printing, registering, issuance, sale, and approval of such bonds.

Sec. 7. Form, Issuance, and Eligibility of Bonds. All bonds issued under the provisions of this Act shall be issued in the name of the [Harris County Flood Control] District [of Harris County, Texas], and shall be signed by the presiding officer [County Judge], attested by the secretary [County Clerk], and the seal of the District [Commissioners Court of Harris County] shall be

- 1 affixed to each of them. Said bonds shall be registered with the Harris County Treasurer and his Certificate of Registration shall 2 3 be endorsed on said bonds. The Board [governing body of the Harris County Flood Control District], in the issuance of bonds voted by 4 the qualified taxpaying voters of said District, or in the issuance 5 of refunding bonds of said District, may issue such bonds in any 6 denomination it deems beneficial to the said District, 7 8 determined in the order authorizing their issuance. The said bonds shall bear interest at a rate not to exceed five (5) percentum per 9 10 annum, which interest shall be evidenced by attached coupons which shall bear the facsimile signatures of the presiding officer 11 12 [County Judge] and of the secretary [County Clerk]. Said interest shall be payable annually or semi-annually as determined by the 13 Board [governing body of the Harris County Flood Control District]. 14 15 The bonds shall mature serially or otherwise in such number of years as may be determined by the Board [Commissioners Court] not to 16 17 exceed thirty (30) years.
- All bonds of the [Harris County Flood Control] District shall be and are hereby declared to be legal and authorized investments for banks, savings banks, trust companies, building and loan associations, savings and loan associations, insurance companies, fiduciaries, trustees and sinking funds of cities, towns and villages, counties, school districts, or other political subdivisions of the State of Texas, and for all public funds of the

Payment of principal and interest may be made at such places

as may be determined by the Board [governing body of such District]

in the Order authorizing the issuance of such bonds.

- 1 State of Texas or its agencies, including the State Permanent
- 2 School Fund. Such bonds shall be eligible to secure deposit of any
- 3 and all public funds of the State of Texas, and any and all public
- 4 funds of cities, towns, villages, counties, school districts or
- 5 other political subdivisions or corporations of the State of Texas;
- 6 and such bonds shall be lawful and sufficient security for said
- 7 deposits to the extent of their value, when accompanied by all
- 8 unmatured coupons appurtenant thereto.
- 9 Sec. 8. State Laws Applicable. All existing State Laws,
- 10 General or Special, applicable to contracts and to the receipt and
- 11 disbursement of, and accounting for, public funds in the District
- 12 [Harris County] are hereby made applicable to the contracts and to
- 13 the receipt and disbursement of, and accounting for, any funds
- 14 collected and disbursed under the terms of this Act. The provisions
- 15 of this Act shall be cumulative of any other laws upon the subject
- 16 matter.
- 17 Sec. 9. Use of Public Property. In the prosecution of the
- 18 flood control plans of the [Harris County Flood Control] District,
- 19 the District shall be recognized to have the right to make use of
- 20 the bed and banks of the bayous, rivers, and streams lying within
- 21 the District, subject to the prior right and authority of the Port
- 22 of [Harris County] Houston Authority of Harris County [Ship Channel
- 23 Navigation District] over the navigable streams in the Authority
- 24 [Navigation District] and the submerged lands heretofore given by
- 25 the State of Texas to that Authority [Navigation District].
- The [Harris County Flood Control] District shall have a right
- 27 of way and easement over and across the roads and highways of the

- 1 State and its subdivisions for the construction and maintenance of
- 2 the flood control projects of the District, subject, however, to
- 3 the concurrence of the <u>Texas Transportation</u> [State Highway]
- 4 Commission whenever such projects require the relocation or
- 5 bridging of State highways.
- 6 The District shall have the power and authority to overflow
- 7 or inundate any public lands and public property, and to require the
- 8 relocation of roads and highways, in the manner and to the extent
- 9 permitted to any district organized under General Laws, pursuant to
- 10 Section 59 of Article XVI of the Constitution of this State, as
- 11 amended.
- 12 Sec. 10. Eminent Domain. The [Harris County Flood Control]
- 13 District shall have the right and power of eminent domain for the
- 14 purpose of acquiring by condemnation any and all property of any
- 15 kind, real, personal, or mixed, or any interest therein, within the
- 16 boundaries of the District, necessary or convenient to the exercise
- 17 of the rights, powers, privileges, and functions conferred upon it
- 18 by this Act, in the manner provided by General Law with respect to
- 19 condemnation, or, at the option of the Board [Commissioners Court],
- 20 in the manner provided by Statutes relative to condemnation by
- 21 districts organized under General Law pursuant to Section 59 of
- 22 Article XVI of the Constitution of the State of Texas, as amended.
- In condemnation proceedings being prosecuted by said
- 24 District, the District shall not be required to give bond for appeal
- 25 or bond for costs.
- Sec. 11. Taxes. All laws of the State of Texas relating to
- 27 the assessing and collecting of State and County Taxes are by this

- 1 Act made available for, and shall be applied to, the collection of
- 2 both current and delinquent taxes of the [Harris County Flood
- 3 Control District in so far as such laws are applicable.
- 4 Sec. 12. Officers. The presiding officer, secretary,
- 5 treasurer, and Board of the District [County Judge, County
- 6 Commissioners], the Assessor and Collector of Taxes of each county
- 7 <u>in the District</u>, [the County Treasurer,] and the <u>District's</u>
- 8 depository are authorized to, and shall be required to, perform all
- 9 duties in connection with the [Flood Control] District required of
- 10 them by law in connection with official matters for [Harris County,
- 11 and the County Auditor shall be the Auditor for] the [Harris County
- 12 Flood Control District [and all of the provisions of Articles 1667
- 13 through 1673, as amended, Acts of the Forty-third Legislature,
- 14 Regular Session, 1933, shall apply to the Harris County Flood
- 15 Control District].
- 16 Sec. 12-a. Tax Collector's Reports. If at any time after
- 17 the enactment of this law, the Legislature of the State of Texas
- 18 shall make any donation or grant or diversion or remission of taxes
- 19 to or affecting a county in the District [Harris County, Texas,] or
- 20 the District [flood control district herein created, in H.B. 24 or
- 21 in H.B. 158, Acts Regular Session, Forty-fifth Legislature], at the
- 22 end of each month [after the effective date of such Act,] the
- 23 Assessor and Collector of Taxes of \underline{each} county in the District
- 24 [Harris County] shall make an itemized report under oath to the
- 25 Comptroller of Public Accounts of the State of Texas on forms to be
- 26 furnished by the Comptroller showing each and every item of the
- 27 State taxes collected by him upon property and from persons within

1 the District; and he shall accompany the same with an itemized statement listing all taxes received and showing full disposal of 2 3 all such taxes collected. The said Assessor and Collector of Taxes shall forward his report to the Comptroller, and shall make a like 4 report to the Treasurer [County Auditor,] and [he shall] pay over to 5 the [County] Treasurer all moneys collected by him as State taxes so 6 donated or granted under Legislative authority, less such amounts 7 8 as are allowed by law for assessing and collecting same, and shall remit the balance to the proper authority as required by then 9 10 existing laws.

The Board [Commissioners Court], in its discretion, may 11 utilize the tax funds donated and granted by the State of Texas for 12 construction of flood control 13 improvements 14 improvements and purposes authorized by such enactments and the 15 maintenance or operation thereof; or may deposit the same in a sinking fund to pay interest on and to redeem bonds of said District 16 17 or other obligations issued for such purposes, in the manner hereinafter provided. 18

19 Sec. 12-b. Issuance of Bonds. The District may [County of Harris, Texas, acting by and through its Commissioners Court, shall 20 have authority and it is hereby authorized to] issue [its] 21 negotiable bonds secured by a pledge of [any such] taxes hereafter 22 23 donated, granted, diverted or remitted by the State of Texas to [it 24 or] the [Flood Control] District [created herein by the terms of H.B. 24 or H.B. 158 of the Regular Session, Forty-fifth 25 26 Legislature], and the proceeds of the sale of such bonds may be used for purchasing lands, easements, right of ways, structures, and for 27

the construction of improvements, including dams, reservoirs, and 1 all other works suitable for use in connection with the flood 2 3 control program and projects in the District [said County] and the maintenance and operation thereof, and doing all things necessary 4 5 to the execution of the purposes for which the grant and donation is made; provided, however, that the aggregate amount of bonds to be 6 issued shall not exceed such sum as the donation and grant of the 7 8 State taxes will service so as to pay interest and to create a sinking fund sufficient to pay said bonds at maturity. 9

In the event the Board [Commissioners Court of Harris County, Texas, shall determine by a majority vote on a Resolution entered of record, giving the reasons therefor and showing that a necessity exists for utilizing any tax funds hereafter donated and granted by the State of Texas for the issuance of bonds in order to facilitate the construction of improvements and make funds immediately available, said bonds may be issued in the form and manner hereinafter prescribed. The bonds so authorized and issued in accordance with the provisions of this Act need not be issued at one The amount of money necessary to provide a sinking fund to mature said bonds and to pay the interest thereon shall be set aside annually from the first of such hereafter donated and granted funds received from an [the] Assessor and Collector of Taxes and said funds may not be diverted to any other purpose. The Board [Officers of the County] and the District's Depository are forbidden to authorize the payment of any amount from said State taxes hereafter 26 so donated and granted until there has first been set aside therefrom an amount sufficient to cover all servicing charges for

- 1 the bonds for the year. Thereupon and after the <u>treasurer</u> [Auditor] has filed a certificate showing the deposit to the interest and 2 3 sinking fund of a sufficient amount to cover such servicing charges for the year, any taxes hereafter donated, granted, diverted or 4 5 remitted to [Harris County or] the [Flood Control] District [created herein by the State of Texas under the terms of H.B. 24 or 6 H.B. 158, Acts Regular Session, Forty-fifth Legislature, 7 8 collected during the remainder of the year may be utilized for purposes consistent with this Act. Should the necessity arise, the 9 Board [Commissioners Court] may supplement from its general funds 10 any State taxes hereafter donated and granted, but no tax shall ever 11 12 be levied or any debt be created against a [the] County in the District for such purpose without a vote of the people. Any bonds 13 14 issued under this Section shall be in accordance with the provisions of Subdivisions 1 and 2 of Title 22, Revised Civil 15
- issued by a county.

 Sec. 12-c. OPERATION OF TOLL PROJECTS. (a) The District

 shall have all the powers and duties of Chapter 284, Transportation

 Code, as if the District were a county to which that chapter

 applies.

Statutes, 1925, and any amendments thereto applicable to bonds

- (b) The District and the commissioners court of Harris
 County shall enter into an agreement for the independent operation
 and transfer of the assets, facilities, and programs of the Harris
 County Toll Road Authority to the District.
- 26 SECTION 2. Section 1, Chapter 406, Acts of the 50th 27 Legislature, Regular Session, 1947, is amended to read as follows:

- 1 Sec. 1. In eminent domain proceedings brought by the Gulf Coast Resiliency [Harris County Flood Control] District, the 2 3 District shall not be required to give any security for costs at any stage of the proceedings. In the event that the District should 4 5 desire to take possession of the property sought to be condemned, it may do so at any time after the award of the Special Commissioners 6 in eminent domain proceedings shall have been filed with the Judge 7 of the County Court in which the proceedings took place, or County 8 Court at Law in which the proceedings took place as the case may be, 9 upon deposit with the County Clerk of the county in which the 10 proceedings took place of the amount of the award. The District 11 12 shall not be required to deposit any further sums, nor to give any bond for costs. No appeal from the finding and assessment of 13 14 damages by the Special Commissioners appointed for that purpose 15 shall have the effect of causing the suspension of work by the District in connection with the land condemned or the right of way, 16 17 easement or other interest sought to be acquired. The findings of the District's governing board [Commissioners Court] as to the plan 18 19 of the work, the necessity, the location and the type of improvement shall be final and not subject to review except upon proof of actual 20 21 fraud or malfeasance in office.
- SECTION 3. Sections 1, 2, and 3, Chapter 407, Acts of the 50th Legislature, Regular Session, 1947, are amended to read as follows:
- Sec. 1. The governing body of the <u>Gulf Coast Resiliency</u>
 [Harris County Flood Control] District, (hereinafter called
 "Board") may upon the petition of fifty (50) or more resident

1 qualified voters who own taxable property in the District and who have rendered it for taxation, order an election for the purpose of 2 3 submitting to the resident qualified voters therein who own taxable property therein and who have duly rendered it for taxation the 4 5 question of whether or not the Board shall be authorized to issue the bonds of said District and to levy a tax for maintenance and 6 operation purposes; provided that the amount of the tax for bonds 7 8 and maintenance together in any one (1) year shall not exceed thirty cents (30¢) on the One Hundred Dollars (\$100) valuation of taxable 9 property in said District. The petition shall conform as near as 10 may be to the requirements of law now governing petitions for 11 election for bonds in such District, and the election shall not be 12 ordered until notice of hearing be published, and public hearing 13 14 had, as now provided by law for the holding of elections for the issuance of bonds in said District. 15

16 Sec. 2. The time, place, manner and method of ordering, 17 giving notice of and holding the election, the questions and propositions to be submitted, the form of the ballot, the time and 18 method of declaring the result and the issuance of the bonds shall 19 be governed as near as may be by the Statutes governing the holding 20 21 of elections and the issuance of [county] bonds as provided in Chapters 1 and 2 of Title 22, Revised Civil Statutes, 1925[, as 22 modified by the Statutes creating the Harris County Flood Control 23 24 District]. The District may issue its bonds to mature serially or otherwise not to exceed thirty (30) years after their date. 25 26 governing body may also determine whether or not bonds shall contain an option of redemption, and if so, the form and date of 27

- 1 such option. If the election be for a maintenance tax, then the
- 2 ballot shall have written or printed thereon the words "For the
- 3 Flood Control Maintenance Tax" and, "Against the Flood Control
- 4 Maintenance Tax," and the voter shall strike out one of said

- 6 authorized, the Board may thereafter levy annually a tax sufficient
- 7 to operate and maintain works and improvements owned or constructed

- 11 bonds bearing the same or a lower rate of interest to refund any

- 14 years not exceeding thirty (30). Statutes governing refunding of
- 15 county bonds shall apply to refunding bonds of the [Harris County
- 16 Flood Control District so far as applicable, except where
- 17 otherwise expressly provided by the laws relating to said District.
- SECTION 4. Section 1, Chapter 258, Acts of the 55th
- 19 Legislature, Regular Session, 1957, is amended to read as follows:
- Sec. 1. The governing body of the Gulf Coast Resiliency
- 21 [Harris County Flood Control] District shall have the right to
- 22 provide for and administer a retirement, disability and death
- 23 compensation fund for the appointive officers and employees of the
- 24 District as the governing body of the District may from time to time
- 25 determine; and the governing body of said District shall have power
- 26 and authority to adopt such plan or plans to effectuate the purpose
- 27 of this Act, including such forms of insurance or annuities,

- 1 (either or both), all as may be determined advisable by the
- 2 governing body of the District; providing that said governing body

- 12 (2) "Waterway" shall include any river, creek, bayou,
- 13 stream or other waterway, or any part thereof.

Before passing any resolution designating flood hazard areas within the boundaries of the [Harris County Flood 11 Control District, the governing body of the [Harris County Flood 12 Control District shall hold at least one public hearing related 13 14 thereto after having given at least fifteen (15) days' notice of the 15 time and place of such hearing by the publication thereof in the English language in a daily newspaper published within and having 16 17 general circulation within the [Harris County Flood Control] District, such publication being at least fifteen (15) days prior 18 19 to the date of the hearing. - Sec. 1. RECREATIONAL AND ENVIRONMENTAL IMPROVEMENTS. (a)
- 22 The <u>Gulf Coast Resiliency</u> [Harris County Flood Control] District,
- 23 in connection with flood control facilities and projects, may
- 24 provide for or participate in the development, operation, or
- 25 maintenance of:

- 17 (g) The exercise of powers, expenditure of funds, and use of
- 18 property by the district under this section are subject to the
- 19 control and discretion of the governing body of the district
- 20 [commissioners court].
- SECTION 8. Section 1, Chapter 410, Acts of the 73rd
- 22 Legislature, Regular Session, 1993, is amended to read as follows:
- Sec. 1. (a) The <u>Gulf Coast Resiliency</u> [Harris County Flood
- 24 Control District may engage in wetlands mitigation projects and
- 25 programs as provided by Article 6, Chapter 3, Acts of the 72nd
- 26 Legislature, 1st Called Session, 1991 (Article 5421u, Vernon's
- 27 Texas Civil Statutes), and its subsequent amendments.

- 1 (b) The [Harris County Flood Control] District may provide
- 2 for or participate in the development, operation, or maintenance of
- 3 local, state, or federal storm water quality control and
- 4 improvement programs.
- 5 SECTION 9. The following provisions are repealed:
- 6 (1) Section 3A, Chapter 360, Acts of the 45th
- 7 Legislature, Regular Session, 1937; and
- 8 (2) Chapter 196, Acts of the 51st Legislature, Regular

- 10 SECTION 10. (a) As soon as practicable after the effective
- 11 date of this Act, the governor shall appoint members to the

- 14 Session, 1937, as added by this Act.
