## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the Fort Bend County Water Control and Improvement District No. 11; granting a limited power of eminent 3 domain; providing authority to issue bonds; providing authority to 4 5 impose assessments, fees, and taxes. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Subtitle I, Title 6, Special District Local Laws 7 Code, is amended by adding Chapter 9064 to read as follows: 8 CHAPTER 9064. FORT BEND COUNTY WATER CONTROL AND IMPROVEMENT 9 DISTRICT NO. 11 10 SUBCHAPTER A. GENERAL PROVISIONS 11 12 Sec. 9064.0101. DEFINITIONS. In this chapter: "Board" means the district's board of directors. 13 (1) (2) "Commission" means the <u>Texas</u> Commission on 14 15 Environmental Quality. 16 (3) "Director" means a board member. (4) "District" means the Fort Bend County Water 17 Control and Improvement District No. 11. 18 Sec. 9064.0102. NATURE OF DISTRICT. The district is a water 19 control and improvement district created under Section 59, Article 20 21 XVI, Texas Constitution. Sec. 9064.0103. CONFIRMATION AND DIRECTOR ELECTION 22 23 REQUIRED. The temporary directors shall hold an election to confirm the creation of the district and to elect five permanent 24

1	directors as provided by Section 49.102, Water Code.
2	Sec. 9064.0104. CONSENT OF MUNICIPALITY REQUIRED. The
3	temporary directors may not hold an election under Section
4	9064.0103 until each municipality in whose corporate limits or
5	extraterritorial jurisdiction the district is located has
6	consented by ordinance or resolution to the creation of the
7	district and to the inclusion of land in the district as required by
8	applicable law.
9	Sec. 9064.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
10	(a) The district is created to serve a public purpose and benefit.
11	(b) The district is created to accomplish the purposes of:
12	(1) a water control and improvement district as
13	provided by general law and Section 59, Article XVI, Texas
14	Constitution, with respect to the gathering, conducting,
15	diverting, and control of local storm water or other harmful
16	excesses of water; and
17	(2) Section 52, Article III, Texas Constitution, that
18	relate to the construction, acquisition, improvement, operation,
19	or maintenance of macadamized, graveled, or paved roads, or
20	improvements, including storm drainage, in aid of those roads.
21	Sec. 9064.0106. INITIAL DISTRICT TERRITORY. (a) The
22	district is initially composed of the territory described by
23	Section 2 of the Act enacting this chapter.
24	(b) The boundaries and field notes contained in Section 2 of
25	the Act enacting this chapter form a closure. A mistake made in the
26	field notes or in copying the field notes in the legislative process
27	does not affect the district's:

1	(1) organization, existence, or validity;
2	(2) right to issue any type of bond for the purposes
3	for which the district is created or to pay the principal of and
4	interest on a bond;
5	(3) right to impose a tax; or
6	(4) legality or operation.
7	SUBCHAPTER B. BOARD OF DIRECTORS
8	Sec. 9064.0201. GOVERNING BODY; TERMS. (a) The district is
9	governed by a board of five elected directors.
10	(b) Except as provided by Section 9064.0202, directors
11	serve staggered four-year terms.
12	Sec. 9064.0202. TEMPORARY DIRECTORS. (a) On or after the
13	effective date of the Act enacting this chapter, the owner or owners
14	of a majority of the assessed value of the real property in the
15	district may submit a petition to the commission requesting that
16	the commission appoint as temporary directors the five persons
17	named in the petition. The commission shall appoint as temporary
18	directors the five persons named in the petition.
19	(b) Temporary directors serve until the earlier of:
20	(1) the date permanent directors are elected under
21	Section 9064.0103; or
22	(2) the fourth anniversary of the effective date of
23	the Act enacting this chapter.
24	(c) If permanent directors have not been elected under
25	Section 9064.0103 and the terms of the temporary directors have
26	expired, successor temporary directors shall be appointed or
27	reappointed as provided by Subsection (d) to serve terms that

1 expire on the earlier of: 2 (1) the date permanent directors are elected under 3 Section 9064.0103; or 4 (2) the fourth an<u>niversary of the date of the</u> 5 appointment or reappointment. 6 (d) If Subsection (c) applies, the owner or owners of a 7 majority of the assessed value of the real property in the district 8 may submit a petition to the commission requesting that the commission appoint as successor temporary directors the five 9 persons named in the petition. The commission shall appoint as 10 successor temporary directors the five persons named in the 11 12 petition. 13 SUBCHAPTER C. POWERS AND DUTIES Sec. 9064.0301. GENERAL POWERS AND DUTIES. The district 14 15 has the powers and duties necessary to accomplish the purposes for which the district is created. 16 17 Sec. 9064.0302. WATER CONTROL AND IMPROVEMENT DISTRICT POWERS AND DUTIES. (a) The district has the powers and duties 18 19 provided by the general law of this state applicable to water control and improvement districts created under Section 59, Article 20 XVI, Texas Constitution, including Chapters 49 and 51, Water Code, 21 22 and specifically including the powers and duties authorized under Subchapter H, Chapter 51, Water Code. 23 24 (b) Notwithstanding any other law, the district may not construct, finance, own, or operate facilities necessary to provide 25 26 water or sanitary sewer services. 27 Sec. 9064.0303. AUTHORITY FOR ROAD PROJECTS. Under Section

1 52, Article III, Texas Constitution, the district may design, 2 acquire, construct, finance, issue bonds for, improve, operate, 3 maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, or paved roads, or 4 5 improvements, including storm drainage, in aid of those roads. 6 Sec. 9064.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A 7 road project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of each 8 municipality in whose corporate limits or extraterritorial 9

10 jurisdiction the road project is located.

11 (b) If a road project is not located in the corporate limits 12 or extraterritorial jurisdiction of a municipality, the road 13 project must meet all applicable construction standards, 14 subdivision requirements, and regulations of each county in which 15 the road project is located.

16 (c) If the state will maintain and operate the road, the 17 <u>Texas Transportation Commission must approve the plans and</u> 18 <u>specifications of the road project.</u>

19 Sec. 9064.0305. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. The district shall comply with all 20 applicable requirements of any ordinance or resolution that is 21 adopted under Section 42.042 or 42.0425, Local Government Code, and 22 23 consents to the creation of the district or to the inclusion of land 24 in the district. Sec. 9064.0306. LIMITATION ON USE OF EMINENT DOMAIN. The 25

26 <u>district may not exercise the power of eminent domain outside the</u> 27 <u>district boundaries to acquire a site or easement for:</u>

4	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
5	Sec. 9064.0401. ELECTIONS REGARDING TAXES OR BONDS. (a)
6	The district may issue, without an election, bonds and other
7	obligations secured by:
8	(1) revenue other than ad valorem taxes; or
9	(2) contract payments described by Section 9064.0403.
10	(b) The district must hold an election in the manner
11	provided by Chapters 49 and 51, Water Code, to obtain voter approval
12	before the district may impose an ad valorem tax or issue bonds
13	payable from ad valorem taxes.
14	(c) The district may not issue bonds payable from ad valorem
15	taxes to finance a road project unless the issuance is approved by a
16	vote of a two-thirds majority of the district voters voting at an
17	election held for that purpose.
18	Sec. 9064.0402. OPERATION AND MAINTENANCE TAX. (a) If
19	authorized at an election held under Section 9064.0401, the
20	district may impose an operation and maintenance tax on taxable
21	property in the district in accordance with Section 49.107, Water
22	<u>Code.</u>
23	(b) The board shall determine the tax rate. The rate may not
24	exceed the rate approved at the election.
25	Sec. 9064.0403. CONTRACT TAXES. (a) In accordance with
26	Section 49.108, Water Code, the district may impose a tax other than
27	an operation and maintenance tax and use the revenue derived from

1 the tax to make payments under a contract after the provisions of 2 the contract have been approved by a majority of the district voters 3 voting at an election held for that purpose. 4 (b) A contract approved by the district voters may contain a 5 provision stating that the contract may be modified or amended by 6 the board without further voter approval. 7 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS Sec. 9064.0501. AUTHORITY TO ISSUE BONDS AND OTHER 8 OBLIGATIONS. The district may issue bonds or other obligations 9 10 payable wholly or partly from ad valorem taxes, impact fees, revenue, contract payments, grants, or other district money, or any 11 12 combination of those sources, to pay for any authorized district 13 purpose. 14 Sec. 9064.0502. TAXES FOR BONDS. At the time the district 15 issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing 16 17 direct ad valorem tax, without limit as to rate or amount, while all or part of the bonds are outstanding as required and in the manner 18 19 provided by Chapter 51, Water Code. Sec. 9064.0503. BONDS FOR ROAD PROJECTS. At the time of 20 issuance, the total principal amount of bonds or other obligations 21 22 issued or incurred to finance road projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the 23 24 real property in the district. Sec. 9064.0504. BONDS FOR RECREATIONAL FACILITIES. (a) 25 26 The district may develop recreational facilities and issue bonds

27 for recreational facilities as provided by Chapter 49, Water Code,

regardless of whether the district's territory overlaps with the 1 territory of a political subdivision that is authorized to develop 2 recreational facilities and issue bonds for recreational 3 facilities under Chapter 49, Water Code. 4 5 (b) The authority of the district to develop recreational facilities and issue bonds for recreational facilities under this 6 7 section does not limit the authority of another political 8 subdivision whose territory the territory of the district may overlap, wholly or partly, to develop recreational facilities and 9 10 issue bonds for recreational facilities under Chapter 49, Water Code. 11

12 SECTION 2. The Fort Bend County Water Control and 13 Improvement District No. 11 initially includes all the territory 14 contained in the following area:

4 SECTION 3. (a) The legal notice of the intention to 5 introduce this Act, setting forth the general substance of this 6 Act, has been published as provided by law, and the notice and a 7 copy of this Act have been furnished to all persons, agencies, 8 officials, or entities to which they are required to be furnished 9 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 10 Government Code.

(b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Environmental Quality.

14 The Texas Commission on Environmental Quality has filed (c)15 its recommendations relating to this Act with the governor, the governor, 16 lieutenant and the speaker of the house of representatives within the required time. 17

18 (d) All requirements of the constitution and laws of this 19 state and the rules and procedures of the legislature with respect 20 to the notice, introduction, and passage of this Act are fulfilled 21 and accomplished.

SECTION 4. (a) Section 9064.0306, Special District Local Laws Code, as added by Section 1 of this Act, takes effect only if this Act receives a two-thirds vote of all the members elected to each house.

(b) If this Act does not receive a two-thirds vote of all the
members elected to each house, Subchapter C, Chapter 9064, Special

District Local Laws Code, as added by Section 1 of this Act, is
 amended by amending Section 9064.0306 to read as follows:

3 <u>Sec. 9064.0306. NO EMINENT DOMAIN POWER. The district may</u>
4 not exercise the power of eminent domain.

5 (c) This section is not intended to be an expression of a 6 legislative interpretation of the requirements of Section 17(c), 7 Article I, Texas Constitution.

8 SECTION 5. This Act takes effect immediately if it receives 9 a vote of two-thirds of all the members elected to each house, as 10 provided by Section 39, Article III, Texas Constitution. If this 11 Act does not receive the vote necessary for immediate effect, this 12 Act takes effect September 1, 2023.
