1	AN ACT
2	relating to the creation of the Cross Timbers Regional Utility
3	Authority; granting a limited power of eminent domain; providing
4	authority to issue bonds; providing authority to impose assessments
5	and fees.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle F, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 7966A to read as follows:
9	CHAPTER 7966A. CROSS TIMBERS REGIONAL UTILITY AUTHORITY
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 7966A.0101. DEFINITIONS. In this chapter:
12	(1) "Authority" means the Cross Timbers Regional
13	Utility Authority.
14	(2) "Board" means the board of directors of the
15	authority.
16	(3) "Director" means a member of the board.
17	Sec. 7966A.0102. NATURE OF AUTHORITY. (a) The authority is
18	a conservation and reclamation district created under Section 59,
19	Article XVI, Texas Constitution.
20	(b) The authority is a political subdivision of this state.
21	Sec. 7966A.0103. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
22	(a) The authority is created to serve a public use and benefit.
23	(b) All land and other property included in the boundaries
24	of the authority will benefit from the works and projects

- 1 accomplished by the authority under the powers conferred by Section
- 2 59, Article XVI, Texas Constitution.
- 3 (c) The creation of the authority is essential to accomplish
- 4 the purposes of Section 59, Article XVI, Texas Constitution.
- 5 SUBCHAPTER B. AUTHORITY TERRITORY
- 6 Sec. 7966A.0201. AUTHORITY TERRITORY. The authority is
- 7 composed of all of the territory contained in Palo Pinto County,
- 8 Parker County, and Stephens County, as that territory may have been
- 9 modified under:
- 10 (1) Subchapter H, Chapter 54, Water Code;
- 11 (2) Subchapter J, Chapter 49, Water Code; or
- 12 (3) other law.
- SUBCHAPTER C. BOARD OF DIRECTORS
- Sec. 7966A.0301. COMPOSITION OF BOARD; TERMS. (a) The
- 15 <u>authority is governed by a board of seven directors.</u>
- 16 (b) Directors are appointed as follows:
- 17 (1) one director appointed by the Commissioners Court
- 18 of Palo Pinto County;
- 19 (2) three directors appointed by the Commissioners
- 20 Court of Parker County;
- 21 (3) one director appointed by the Commissioners Court
- 22 of Stephens County; and
- 23 (4) two directors appointed by the city council of the
- 24 City of Mineral Wells.
- 25 (c) Directors serve staggered four-year terms. Directors
- 26 may not serve more than two terms.
- 27 (d) When a director's term expires, the appointing entity

- 1 shall appoint a successor.
- 2 (e) The board shall select a presiding officer from among
- 3 the directors who have served on the board for at least two years to
- 4 serve in that position for the remainder of the director's term.
- 5 Sec. 7966A.0302. QUALIFICATIONS FOR OFFICE. (a) Each
- 6 director must be a qualified voter of the county or municipality
- 7 that appoints the director.
- 8 (b) An officer, employee, or member of an appointing entity
- 9 may not be a director.
- Sec. 7966A.0303. BOARD VACANCY. A vacancy in the office of
- 11 director shall be filled for the unexpired term, if applicable, by
- 12 the appointing entity that appointed the previous director.
- Sec. 7966A.0304. REMOVAL FROM OFFICE. (a) Under
- 14 procedures adopted by board rule, the board may remove a director
- 15 <u>from office only for malfeasance in office.</u>
- 16 (b) The procedures must be designed to guarantee due process
- 17 to the director.
- 18 Sec. 7966A.0305. VOTING REQUIREMENT. A majority vote of
- 19 the board is required to adopt any measure.
- 20 SUBCHAPTER D. POWERS AND DUTIES
- Sec. 7966A.0401. MUNICIPAL UTILITY DISTRICT POWERS. Except
- 22 as otherwise provided by this chapter, the authority has the
- 23 rights, powers, privileges, and functions conferred and imposed by
- 24 the general law applicable to a municipal utility district created
- 25 under Section 59, Article XVI, Texas Constitution, including those
- 26 conferred by Chapters 30, 49, and 54, Water Code.
- Sec. 7966A.0402. ACQUISITION AND USE OF PROPERTY. The

- 1 authority may operate, control, purchase, construct, lease, or
- 2 acquire, inside or outside the boundaries of the authority,
- 3 property, works, facilities, or improvements, whether previously
- 4 existing or to be made, constructed, or acquired, that the board
- 5 finds necessary to carry out the powers granted by this chapter or
- 6 general law.
- 7 Sec. 7966A.0403. WATER RIGHTS. The authority may acquire,
- 8 develop, and use rights to groundwater or surface water.
- 9 Sec. 7966A.0404. EMINENT DOMAIN. To carry out an authority
- 10 power or purpose, the authority, in the manner provided by Chapter
- 11 49, Water Code, may exercise the power of eminent domain to acquire
- 12 land, an easement, or other property inside or outside the
- 13 authority's boundaries.
- 14 Sec. 7966A.0405. GENERAL CONTRACT POWERS. (a) The
- 15 authority may enter into a contract with a person, including a
- 16 political subdivision, on terms the board considers desirable,
- 17 fair, and advantageous for:
- 18 <u>(1) the purchase or sale of raw or treated water;</u>
- 19 (2) the purchase, lease, use, management, control, or
- 20 operation of water treatment or distribution facilities or sewer
- 21 collection and treatment facilities, all or part of the facilities
- 22 or systems owned by the other political subdivision, in accordance
- 23 with terms mutually agreed on by the governing bodies of the
- 24 contracting parties; or
- 25 (3) planning, making preliminary surveys,
- 26 investigations, or feasibility reports, engineering, or reports of
- 27 any kind.

- 1 (b) A contract for the acquisition of an existing water or
- 2 sewer facility may be made on terms approved by the contracting
- 3 parties.
- 4 (c) If changes in plans or specifications are necessary
- 5 after performance of a construction contract begins, the board may
- 6 approve change orders necessary to decrease or increase the amount
- 7 of materials, equipment, or supplies to be provided under the
- 8 contract or the amount of work to be performed. The total cost of
- 9 the change orders may not increase the original contract price by
- 10 more than 25 percent.
- 11 Sec. 7966A.0406. WATER, SEWER, SOLID WASTE, OR DRAINAGE
- 12 CONTRACTS; ELECTION NOT REQUIRED. The authority and a municipal
- 13 corporation or other political subdivision may enter into a water,
- 14 sewer, solid waste, or drainage contract or any combination of
- 15 those contracts without the necessity of an election by any
- 16 contracting party to approve the contract.
- 17 Sec. 7966A.0407. TREATMENT OF PAYMENTS UNDER CERTAIN
- 18 MUNICIPAL CORPORATION CONTRACTS. A payment by a municipal
- 19 corporation for the purchase of water or the treatment and disposal
- 20 of sewage is a maintenance and operating expense of the utility
- 21 system or combined systems of the municipal corporation unless the
- 22 contract:
- 23 (1) provides for the municipal corporation to acquire
- 24 an ownership interest in the facilities; or
- 25 (2) makes other provisions.
- Sec. 7966A.0408. TAX PROHIBITION. The authority may not
- 27 impose a tax.

SUBCHAPTER E. BONDS

- Sec. 7966A.0501. REVENUE BONDS. The authority may issue
- 3 revenue bonds to carry out any of its powers, functions, or
- 4 obligations.

- 5 Sec. 7966A.0502. BONDS FOR CERTAIN FACILITIES. If the
- 6 authority operates a facility under contract with a municipal
- 7 corporation, it may, if the contract permits the issuance, issue
- 8 bonds to improve or extend the facility.
- 9 SECTION 2. (a) Not later than the 45th day after the
- 10 effective date of this Act, the city council of the City of Mineral
- 11 Wells and the commissioners courts of Palo Pinto County, Parker
- 12 County, and Stephens County each shall appoint the appropriate
- 13 number of directors to the board of directors of the Cross Timbers
- 14 Regional Utility Authority as required under Section 7966A.0301,
- 15 Special District Local Laws Code, as added by this Act.
- 16 (b) Notwithstanding Section 7966A.0301(e), Special
- 17 District Local Laws Code, as added by this Act, at the first meeting
- 18 of the board of directors of the Cross Timbers Regional Utility
- 19 Authority after the effective date of this Act, the board shall
- 20 select a presiding officer from among the directors appointed under
- 21 Subsection (a) of this section to serve as presiding officer for the
- 22 remainder of the director's term.
- (c) The presiding officer selected under Subsection (b) of
- 24 this section will serve an initial term that expires January 1,
- 25 2027. The six other directors appointed under Subsection (a) of
- 26 this section shall draw lots to determine which three directors
- 27 will serve initial terms that expire on January 1, 2025, and which

- 1 three directors will serve initial terms that expire January 1,
- 2 2027.
- 3 SECTION 3. (a) The legal notice of the intention to
- 4 introduce this Act, setting forth the general substance of this
- 5 Act, has been published as provided by law, and the notice and a
- 6 copy of this Act have been furnished to all persons, agencies,
- 7 officials, or entities to which they are required to be furnished
- 8 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 9 Government Code.
- 10 (b) The governor, one of the required recipients, has
- 11 submitted the notice and Act to the Texas Commission on
- 12 Environmental Quality.
- 13 (c) The Texas Commission on Environmental Quality has filed
- 14 its recommendations relating to this Act with the governor, the
- 15 lieutenant governor, and the speaker of the house of
- 16 representatives within the required time.
- 17 (d) All requirements of the constitution and laws of this
- 18 state and the rules and procedures of the legislature with respect
- 19 to the notice, introduction, and passage of this Act are fulfilled
- 20 and accomplished.
- SECTION 4. (a) Section 7966A.0404, Special District Local
- 22 Laws Code, as added by Section 1 of this Act, takes effect only if
- 23 this Act receives a two-thirds vote of all the members elected to
- 24 each house.
- 25 (b) If this Act does not receive a two-thirds vote of all the
- 26 members elected to each house, Subchapter D, Chapter 7966A, Special
- 27 District Local Laws Code, as added by Section 1 of this Act, is

- Sec. 7966A.0404. NO EMINENT DOMAIN POWER. The authority
- 3 may not exercise the power of eminent domain.
- 4 SECTION 5. This Act takes effect September 1, 2023.
