1 to the limitations imposed by that section. 2 SECTION 2. Section 31.0515, Natural Resources Code, is amended to read as follows: 3 4 Sec. 31.0515. DUTIES RELATED TO THE ALAMO COMPLEX. (a) The 5 land office shall: 6 (1) employ staff necessary to preserve and maintain 7 the Alamo complex and contract for professional services of 8 qualified consultants; [and] (2) commission as a peace officer an Alamo complex 9 ranger who has been certified as qualified to be a peace officer by 10 the Texas Commission on Law Enforcement; and 11 12 (3) prepare an annual budget and work plan, including preservation, future construction, and usual maintenance for the 13 14 Alamo complex, including buildings on the Alamo property, their 15 contents, and their grounds. 16 (b) An Alamo complex ranger commissioned as a peace officer 17 under this section has the powers, privileges, and immunities of a peace officer while carrying out duties as an Alamo complex ranger 18 19 under this section. SECTION 3. This Act takes effect September 1, 2023. 20
