- 1 WHEREAS, Edward Runyan is being inducted into the Petroleum
- 2 Hall of Fame on April 30, 2023; and
- 3 WHEREAS, Based at the Permian Basin Petroleum Museum in
- 4 Midland, the Petroleum Hall of Fame recognizes individuals who have
- 5 made outstanding contributions to the development of the petroleum
- 6 industry in the region; and
- WHEREAS, Ed Runyan is an alumnus of the University of Tulsa,
- 8 where he earned both a bachelor's degree and a master's degree in
- 9 petroleum engineering; he began his career as a reservoir engineer
- 10 at Sohio Petroleum Co., before serving in the United States Army and
- 11 then moving to Midland to become a district engineer for Sohio in
- 12 1960; he continued acquiring experience in the industry while
- 13 working for Permian Enterprises and Elcor Chemical Corporation,
- 14 where he was named vice president of the corporation and president
- 15 of its Agriculture Chemicals Division in 1963; and
- WHEREAS, In 1969, Mr. Runyan founded Weeks Petroleum Ltd.,
- 17 which later became Bell Petroleum Services; he subsequently
- 18 established Texon Oil Company, and in 1990, he acquired a
- 19 controlling interest in Mid-America Petroleum, which he made
- 20 private and renamed Seaboard Oil Company; over the past quarter of a
- 21 century, Texon and Seaboard have been credited with the discovery
- 22 of several significant oil fields; and
- WHEREAS, Mr. Runyan has earned the respect and admiration of
- 24 his professional peers through his service in roles such as

- 1 president of the Society of Petroleum Engineers, chair of the SPE
- 2 Foundation, and president of the American Institute of Mining,
- 3 Metallurgical, and Petroleum Engineers; he and his wife, Marilee
- 4 Runyan, are also longtime supporters of the University of Tulsa,
- 5 which honored him as a Distinguished Alumnus in 1978; and
- 6 WHEREAS, Ed Runyan has built a reputation as a dynamic leader
- 7 and innovator in the petroleum industry, and he may indeed take
- 8 pride in this prestigious recognition of his lifetime achievements;
- 9 now, therefore, be it
- 10 RESOLVED, That the 88th Legislature of the State of Texas
- 11 hereby congratulate Edward Runyan on his induction into the
- 12 Petroleum Hall of Fame and extend to him sincere best wishes for the
