A JOINT RESOLUTION

1 proposing a constitutional amendment creating the state school

2 safety fund to provide financial support for projects that enhance

4 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Article VII, Texas Constitution, is amended by

6 adding Section 7 to read as follows:

7 Sec. 7. (a) The state school safety fund is created as a

8 special fund in the state treasury outside the general revenue

9 fund. Money in the state school safety fund shall be administered,

10 without further appropriation, by the Texas Permanent School Fund

11 Corporation or that corporation's successor in function. In

12 accordance with general law, the state school safety fund may be

used only to support projects to enhance the safety of public

schools in this state, including projects to ensure public schools

15 meet school safety standards established by the Texas Education

16 Agency or that agency's successor in function. Separate accounts

17 may be established in the state school safety fund as necessary or

18 convenient to administer the fund or the supported projects.

19 (b) The legislature by general law may authorize the Texas

20 Permanent School Fund Corporation or that corporation's successor

in function to provide money from the state school safety fund to

23 for purposes of providing financial assistance, including by direct

- 4 (1) money appropriated to the fund;
- 5 (2) money transferred or deposited to the credit of
- 6 the fund by general law, including money from any source

- 8 of the Texas Permanent School Fund Corporation or the Texas
- 9 Education Agency or that corporation's or agency's successor in

- 13 (4) investment earnings and interest earned on amounts
- 14 credited to the fund;

- 3 (e) For the purposes of Section 22, Article VIII, of this
- 4 constitution, an appropriation of money from the economic
- 5 stabilization fund for the purpose of depositing that money to the
- 6 credit of the state school safety fund is considered to be an
- 7 appropriation of state tax revenues dedicated by this constitution.
- 8 (f) This section is intended to establish a basic framework
- 9 of the state school safety fund, and the legislature by general law
- 10 may provide for the implementation and effectuate the design and
- 11 objects of this section and may delegate duties, responsibilities,
- 12 functions, and authority to the Texas Permanent School Fund
- 13 Corporation or the Texas Education Agency or that corporation's or
- 14 agency's successor in function for those purposes.
- 15 SECTION 2. This proposed constitutional amendment shall be
- 16 submitted to the voters at an election to be held November 7, 2023.
- 17 The ballot shall be printed to permit voting for or against the
- 18 proposition: "The constitutional amendment creating the state
- 19 school safety fund to provide financial support for projects that
- 20 enhance the safety of public schools in this state."
