1 WHEREAS, Proud members of the Alpha Phi Alpha Fraternity are 2 gathering at the State Capitol on January 24, 2023, providing a fitting opportunity to celebrate the fraternity's exceptional 3 legacy of civic engagement; and 4 5 WHEREAS, Launched at Cornell University on December 4, 1906, Alpha Phi Alpha was the first intercollegiate Greek-letter 6 7 fraternity established by African Americans; founded by seven men who came to be known as the "Jewels" of the organization, Alpha Phi 8 9 Alpha initially served as a study and support group for minority students who were struggling against racial prejudice; these early

11 leaders laid the foundation for the fraternity's principles of

12 scholarship, fellowship, character, and the uplifting of humanity;

14 WHEREAS, In the years that followed, Alpha Phi Alpha chapters were formed at other colleges across the nation; while the 15 16 fraternity placed a strong emphasis on the academic excellence of its members, it also expanded its focus to address the educational, 17 economic, political, and social injustices faced by African 18 Americans and people of color around the world; over the decades, 19 20 many former Alpha Phi Alpha members have stood at the forefront of 21 the fight for civil rights, including W. E. B. Du Bois, Paul Robeson, Dr. Martin Luther King Jr., Thurgood Marshall, Adam 22 23 Clayton Powell Jr., Edward Brooke, Andrew Young, and William Gray;

- 4 which has been home to three of the organization's general

- 6 Alpha alumni; and
- WHEREAS, For more than a century, Alpha Phi Alpha has worked
- 8 to foster a brotherhood of concerned citizens who devote themselves
- 9 to the greater good, and its members may indeed reflect with pride
- 10 on their organization's noteworthy tradition of activism and
