- 1 WHEREAS, The City of Giddings dedicated February 1, 2023, as
- 2 Marshall and Charles Etta Francis Family Day, providing a fitting
- 3 opportunity to recognize these outstanding Texans; and
- 4 WHEREAS, Marshall and Charles Etta Francis are the proud
- 5 parents of four sons, Tony, Michael, Brian, and the late Elton
- 6 Francis, who passed away in 2006; the Francises settled in Giddings
- 7 in 1975, and each member of the family has made notable
- 8 contributions to the community over the past 47 years; and
- 9 WHEREAS, Charles Etta Francis was employed as a teacher's
- 10 aide at Giddings State School for two decades, and she has worked
- 11 tirelessly to benefit the wider community; she has played an
- 12 instrumental role in fundraising initiatives for Texas Relay for
- 13 Life, and she served as the team captain of Churches Coming Together
- 14 to Kick Out Cancer in 2022; she was named Outstanding Citizen of the
- 15 Year by the City of Giddings in 2004; and
- 16 WHEREAS, Marshall Francis retired as a tech sergeant in the
- 17 U.S. Air Force in 1975, after 20 years of dedicated service; he
- 18 later worked as a supervisor at the Giddings State School for more
- 19 than two decades, and he served two terms as an elected member of
- 20 the Giddings School Board; in addition, Mr. and Mrs. Francis were
- 21 longtime co-owners of C.E.F. Floral; and
- 22 WHEREAS, Elton Francis graduated from Giddings High School in
- 23 1977 and went on to serve in the U.S. Air Force; he attended Texas
- 24 State University and participated in the track team, holding the

- 1 100-meter record for more than 40 years; in 1980, he qualified in
- 2 the U.S. Track and Field Olympic trials; he enjoyed a rewarding
- 3 career with the Texas School for the Deaf, and he served as a track
- 4 coach for youth in Lee County; and
- 5 WHEREAS, After graduating from Giddings High School in 1979,
- 6 Tony Francis joined the U.S. Army; he later retired from a 29-year
- 7 career at Giddings State School, and he worked in the Parks and
- 8 Maintenance Department for the City of Giddings; since 1982, he and
- 9 his wife have mentored several generations of area youth as coaches
- 10 for the Lee County Express Track Club; currently, he co-owns
- 11 Francis Lawn Care Service, and he serves as a board member for the
- 12 Giddings Economic Development Corporation; and
- WHEREAS, A 1980 graduate of Giddings High School, Michael
- 14 Francis ran track at Texas State University, where he earned a
- 15 bachelor's degree in finance and a master's degree in business
- 16 administration; he has held a number of leadership positions in
- 17 finance and human resources with major companies as well as the
- 18 federal government; today, he is employed as a management
- 19 consultant in Travis, Lee, Williamson, and Bastrop Counties; and
- 20 WHEREAS, Brian Francis graduated from Giddings High School in
- 21 1983 and later earned a bachelor's degree in finance from Texas
- 22 State University as well as a master's degree in business
- 23 administration from St. Edward's University; following a
- 24 three-decade career with the State of Texas, he retired as
- 25 executive director of the Texas Department of Licensing and
- 26 Regulation in 2022; he has been an active supporter of human rights,
- 27 executive leadership, and child trafficking prevention

- 1 initiatives, and he has served on a number of state and local
- 2 boards, including the Texas State University Development
- 3 Foundation Board of Trustees; and
- WHEREAS, The members of the Francis family have made a
- 5 meaningful difference in the Giddings community and beyond, and
- 6 they may indeed take great pride in their many accomplishments;
- 7 now, therefore, be it
- 8 RESOLVED, That the House of Representatives of the 88th Texas
- 9 Legislature hereby honor the Francis family of Giddings on the
- 10 occasion of Marshall and Charles Etta Francis Family Day and extend
- 11 to them sincere best wishes for the future; and, be it further
