- 1 WHEREAS, Members of St. Luke "Community" United Methodist
- 2 Church in Dallas are celebrating the 90th anniversary of their
- 3 church's founding in 2023; and
- WHEREAS, In 1933, the congregation was organized as St. Paul
- 5 Mission Church by ministers from St. Paul United Methodist Church
- 6 downtown, who recognized a need in East Dallas; the first small
- 7 structure built by members was destroyed by a fire in 1941, but four
- 8 years later, they completed a new red brick sanctuary on Wahoo
- 9 Street and Spring Avenue; and
- 10 WHEREAS, The congregation became St. Luke Methodist Church
- 11 in the late 1950s; it moved to its present-day campus in 1974, under
- 12 the leadership of longtime pastor Zan W. Holmes Jr., who also added
- 13 the word "Community" to its name; in 2017, St. Luke transferred its
- 14 old Wahoo Street property to the Zan Wesley Holmes Jr. Community
- 15 Outreach Center to support its good works; and
- WHEREAS, Since July 2020, the church has been ably guided by
- 17 senior pastor Richie Butler; he worked tirelessly to maintain the
- 18 congregation's cohesion during the upheaval of the COVID-19
- 19 pandemic and following major storm damage to the church in spring
- 20 2021; while repairs were underway, Highland Park United Methodist
- 21 Church shared its facilities; and
- 22 WHEREAS, St. Luke sponsors a variety of initiatives
- 23 benefiting the wider community, including donations of food and
- 24 clothing, eviction prevention, and emergency and temporary

- 1 shelter; it has partnered with Harvest Project to distribute fresh
- 2 fruits and vegetables and with Project Unity to offer COVID-19
- 3 vaccinations and testing; moreover, it assists children of
- 4 incarcerated parents and youth in foster care; and
- 5 WHEREAS, For nine decades, St. Luke has provided area
- 6 residents with opportunities for spiritual growth, fellowship, and
- 7 community outreach, and its continued existence is a tribute to the
- 8 unwavering commitment of its members, both past and present; now,
- 9 therefore, be it
- 10 RESOLVED, That the House of Representatives of the 88th Texas
- 11 Legislature hereby congratulate St. Luke "Community" United
- 12 Methodist Church on its 90th anniversary and extend to its members
- 13 sincere best wishes for the future; and, be it further
