- 1 WHEREAS, The life of an admired public servant drew to a close
- 2 with the passing of Palmhurst mayor Ramiro Jose Rodriguez Jr. on
- 3 April 5, 2022, at the age of 68; and
- WHEREAS, Born in San Juan on October 16, 1953, to Ramiro and
- 5 Elvia Rodriguez, Ramiro Rodriguez Jr. grew up with the
- 6 companionship of five sisters, Gloria, Illiana, Eliseo, Mary, and
- 7 Carol, and a brother, Frank; he graduated from Peacock Military
- 8 Academy in San Antonio and earned his bachelor's degree in biology
- 9 from Pan American University; and
- 10 WHEREAS, Mr. Rodriguez distinguished himself through his
- 11 service to the communities of McAllen, Mission, and Pharr, which
- 12 included work for the Pharr city manager's office; he also pursued a
- 13 25-year career in pharmaceutical sales for Wyeth Pharmaceuticals,
- 14 Inc., during which time he earned top awards from the company as one
- 15 of its most successful employees; and
- 16 WHEREAS, After retiring from Wyeth, Mr. Rodriguez
- 17 successfully ran for the office of mayor of Palmhurst; from 1999
- 18 until his passing, he guided the growth of the small town into a
- 19 thriving community, and some of his most significant achievements
- 20 included overseeing the establishment of the city's first police
- 21 department and municipal court and attracting major employers to
- 22 Palmhurst, such as Walmart, H-E-B, and Walgreens, which have
- 23 greatly added to the quality of life in the area; and
- 24 WHEREAS, Along the way, Mr. Rodriguez shared his insight for

- 1 four years as Region 12 director of the Texas Municipal League, in
- 2 addition to volunteering his time on various other boards and
- 3 committees; he was an advocate for small cities, and during the
- 4 COVID-19 pandemic, he fought to ensure that they received a fair
- 5 allocation of crisis funding; and
- 6 WHEREAS, In all his endeavors, Mayor Rodriguez enjoyed the
- 7 love and support of his wife of 43 years, Elda Rodriguez, and their
- 8 son, Ramiro; he was an avid bowler who competed in the Flamingo and
- 9 Mission Valley Classic League for over 30 years, and he also held
- 10 membership in the Knights of Columbus, St. Paul's Chapter, and the
- 11 Rosicrucian Order; and
- 12 WHEREAS, This esteemed Texan has left behind a legacy that
- 13 will long resonate in the communities he served, and he will forever
- 14 be remembered with deep affection by all who held him close to their
- 15 hearts; now, therefore, be it
