- 1 WHEREAS, The Texas Forestry Association is sponsoring a
- 2 seedling giveaway on March 21, 2023, in an effort to promote public
- 3 awareness of working forests and the importance of our state's
- 4 timber resources; and
- 5 WHEREAS, Each year, family forest owners and timberland
- 6 investors plant 83 million seedlings to help maintain sustainable
- 7 forests for future generations of Texans; and
- 8 WHEREAS, The forest sector in Texas covers more than 12
- 9 million acres and directly employs over 70,000 people, with a total
- 10 economic impact of more than \$41.6 billion, making timber a
- 11 valuable agricultural commodity statewide; Texas loggers harvest
- 12 over 18 million tons of trees and haul over 642,000 loads of wood
- 13 from landowners to mills for conversion into affordable and
- 14 sustainable products; and
- WHEREAS, Forests in the Lone Star State sequester 58,836 tons
- 16 of carbon from the atmosphere every day, equivalent to the amount
- 17 emitted by 11,603 passenger vehicles in an entire year; they
- 18 capture 1,000 tons of carbon every 24.5 minutes, and 1 ton of carbon
- 19 is converted into lumber and paper products every 6.27 seconds; and
- 20 WHEREAS, Founded in 1914 by a group of dedicated
- 21 conservationists, the Texas Forestry Association is a nonprofit
- 22 organization committed to advancing forestry management, promoting
- 23 conservation practices, and supporting and protecting the
- 24 interests of the working forests of Texas; TFA offers programs such

- 1 as the Sustainable Forestry Initiative and Tree Farm certifications
- 2 to educate the public and encourage reforestation, with the
- 3 understanding that best management practices are essential for
- 4 productive forests; and
- 5 WHEREAS, The Texas Forestry Association has tirelessly
- 6 worked to ensure that abundant forests remain a dependable resource
- 7 for the citizens of Texas, providing clean water, supporting
- 8 healthy living, and helping to maintain a robust economy, and under
- 9 the able leadership of current president Angela Shannon, TFA will
- 10 undoubtedly continue to contribute to the economic vitality and
- 11 beauty of the Lone Star State; now, therefore, be it
- 12 RESOLVED, That the House of Representatives of the 88th Texas
