1           WHEREAS, Brian McCoy concluded his tenure as chief executive  
2 officer of McCoy's Building Supply on May 31, 2022, following more  
3 than two decades at the helm of the organization; and

4           WHEREAS, Based in San Marcos, McCoy's Building Supply was  
5 founded by Mr. McCoy's grandfather, Frank McCoy, in 1927; Brian  
6 McCoy has been involved with the company for 50 years, and he has  
7 held a variety of positions, including yard hand, truck driver,  
8 floor salesperson, assistant store manager, store manager,  
9 merchandise manager, vice president, and copresident; he became  
10 president and CEO in 2001, and he also serves as chair of the board  
11 of directors; with his retirement, Meagan McCoy Jones, Mr. McCoy's  
12 daughter, takes over as president and CEO of the family-owned  
13 business, which today encompasses 90 locations across five states;

15           WHEREAS, In addition to his work with McCoy's Building  
16 Supply, Mr. McCoy is a partner in McCoy Remme Ranches, and he serves  
17 as board president of the Emmett and Miriam McCoy College of  
18 Business Administration Development Foundation at Texas State  
19 University; he is a former board president of the Lumbermen's  
20 Association of Texas; and

21           WHEREAS, Among his many honors, Mr. McCoy received the 2003  
22 Ethics in Business Award from the Samaritan Center in Austin, and he  
23 was named the 2004 Business Person of the Year by the San Marcos  
24 Area Chamber of Commerce; he holds a bachelor's degree in finance

1 from Texas Tech University, and in 2006, he was recognized as a  
2 Distinguished Alumnus of the Rawls College of Business; in 2012, he  
3 received a Distinguished Alumni Award from the Texas Tech Alumni  
4 Association; and

5 WHEREAS, Brian McCoy's visionary leadership and unwavering  
6 commitment to excellence have played a vital role in the success of  
7 McCoy's Building Supply, and he may indeed reflect with pride on his  
8 contributions to this respected Texas company; now, therefore, be  
9 it

10 RESOLVED, That the House of Representatives of the 88th Texas  
11 Legislature hereby congratulate Brian McCoy on his retirement as  
12 CEO of McCoy's Building Supply and extend to him sincere best wishes
