## RESOLUTION

1 WHEREAS, The city of Nacogdoches lost an esteemed surgeon and 2 a beloved member of the community with the passing of Dr. Larry 3 Walker on December 16, 2021, at the age of 81; and WHEREAS, Born in De Kalb on July 19, 1949, to Enois and Leon 4 5 Walker, Larry Walker grew up with the companionship of two younger brothers, Luke and Howard; he went on to graduate from Texas A&M 6 7 University-Commerce and Baylor College of Medicine, and he subsequently enlisted in the United States Army; from 1969 to 1970, 8 9 he served as captain of the Bravo Company Medical Battalion during the Vietnam War, distinguishing himself through his work as a 10 11 brigade surgeon and earning both a Bronze Star and an Army 12 Commendation Medal; after receiving an honorable discharge, he completed his surgical residency at Ben Taub Hospital, and he and 13 14 other residents at the hospital were featured in a 1970 issue of Life magazine; and 15 WHEREAS, In the early 1970s, Dr. Walker moved to Nacogdoches 16 and established a private surgical practice at Nacogdoches Memorial 17 Hospital; he served as a general and trauma surgeon and as the 18 hospital's chief of surgery up until his retirement in 2017, and he 19 20 was instrumental in opening its chemotherapy department 21 establishing the East Texas Community Health Clinic; his commitment to excellence brought out the best in the staff who worked under 22 23 him, and at times, his deep concern for the patients he treated led

him to waive medical costs for those who were unable to pay; and

- 2 director at Nacogdoches Memorial, and he served on the boards of the
- 3 Nacogdoches County Hospital District, as well as the Samaritan
- 4 Center, the East Texas Treatment Center, Friends of Music at
- 5 Stephen F. Austin State University, and Texas A&M
- 6 University-Commerce; he was recognized as an Outstanding Alumnus of
- 7 Texas A&M University-Commerce in 2012; and
- 8 WHEREAS, In all his endeavors, Dr. Walker enjoyed the love
- 9 and support of his wife of 56 years, Diana Walker, and he took great
- 10 pride in his sons, Andrew, Craig, and Kevin, and his grandchildren,
- 11 Sophia, Liam, Logan, and Sylvia; and
- 12 WHEREAS, Dr. Larry Walker dedicated his life to healing and
- 13 helping others, and he leaves behind a legacy of compassion and
- 14 selflessness that will long be treasured by all those who held him
- 15 dear; now, therefore, be it
